10 (c) AVAILABILITY OF AMOUNTS.—Section 3044 of
11 the Safe, Accountable, Flexible, Efficient Transportation
12 Equity Act: A Legacy for Users (119 Stat. 1652) is
13 amended by adding at the end the following:

14 “(d) AVAILABILITY OF AMOUNTS.—Amounts made
15 available for a project for fiscal year 2006 pursuant to
16 subsection (a) shall be available for that project for obliga-
17 tion until September 30, 2009.”.

18 **SEC. 3. ~~UNITED~~ CARRIER REGISTRATION SYSTEM DEFINI-**
19 **TION CORRECTIONS.**

20 Section 14504a of title 49, United States Code, is
21 amended—

22 (1) in subsection (a)—
23 (A) in the matter preceding paragraph (1),
24 by inserting “(except as provided in paragraph
25 (5))” after “14506”;

1 (B) in paragraph (1), by striking subpara-
2 graph (A) and inserting the following:

3 “(A) IN GENERAL.—Except as provided in
4 subparagraph (B), the term ‘commercial motor
5 vehicle’—

6 “(i) for calendar years 2008 and
7 2009, has the meaning given the term in
8 section 31101; and

9 “(ii) for years beginning after Decem-
10 ber 31, 2009, means a self-propelled vehi-
11 cle described in section 31101.”; and

12 (C) by striking paragraph (5) and insert-
13 ing the following:

14 “(5) MOTOR CARRIER.—

15 “(A) THIS SECTION.—In this section:

16 “(i) IN GENERAL.—The term ‘motor
17 carrier’ includes all carriers that are other-
18 wise exempt from this part—

19 “(I) under subchapter I of chap-
20 ter 135; or

21 “(II) through exemption actions
22 by the former Interstate Commerce
23 Commission under this title.

24 “(ii) EXCLUSIONS.—In this section,
25 the term ‘motor carrier’ does not include—

1 “(I) any carrier subject to section
2 13504; or

3 “(II) any other carrier that the
4 board of directors of the unified car-
5 rier registration plan determines to be
6 appropriate pursuant to subsection
7 (d)(4)(C).

8 “(B) SECTION 14506.—In section 14506,
9 the term ‘motor carrier’ includes all carriers
10 that are otherwise exempt from this part—

11 “(i) under subchapter I of chapter
12 135; or

13 “(ii) through exemption actions by the
14 former Interstate Commerce Commission
15 under this title.”; and

16 (2) in subsection (d)(4)(C), by inserting before
17 the period at the end the following: “, except that
18 a decision to approve the exclusion of carriers from
19 the definition of the term ‘motor carrier’ under sub-
20 section (a)(5) shall require an affirmative vote of $\frac{3}{4}$
21 of all such directors.”.
