Dear Applicant,

Thank you for your interest in AAMVA's Courtesy Verification Program (CVP). The CVP is a free service provided to those members of the Association that are striving to achieve compliance and conformance to specific standards or best practices.

The principal user of the CVP will have a machine-readable motor vehicle document and wish to ascertain whether or not it conforms to a particular standard. This would cover the human-readable (visible) attributes, the physical security features, the encoded data in machine-readable technologies, and durability of the document. The analysis performed by the third-party laboratories serve to identify those areas, if any, that are deficient and provide direction on how and where corrective measures should be taken. For this purpose, we ask that samples created for testing reflect the actual (or intended) issued document. Please note that two (2) separate sets of documents are required if full testing is desired. This covers the above – if an issuing authority is only interested in an aspect of testing then only one set of cards is then required.

Our goal is to enable our members to communicate with one another at a level that allows for full interoperability. Additionally, to know without reliance on a contracted party (vendor) that the product being assessed is, in fact, what they are paying for and performs at the desired specified level.

The CVP service is available at any time and to anyone within the motor vehicle authority arena. For optimal results jurisdictions are encouraged to contact AAMVA while in development so any problem areas that may exist can be addressed prior to rollout or full implementation.

Sample Document Inventory

Instructions: To assist us in performing the best possible analysis of your documents, it is important that we not only have enough samples to test, but all types being used. All samples should be different DL/ID numbers, and if possible, include at least 2 samples for each class of issuance. In some Jurisdictions, there may be over a dozen different types. Our ability to review the encoding of the different classes helps us to analyze and determine if there are any discrepancies of encoding, possibly identifying encoding programming errors or issues. If you are re-sending documents after making changes, it is important to reissue documents with the same exact data as the prior set of samples. This permits us to do a character by character comparison before and after the changes are made.
