U.S. Department of Homeland Security Extends REAL ID to October 1, 2021

The United States Department of Homeland Security (DHS) has [announced](#) that it is extending the REAL ID Act of 2005 (P.L. 109-13) until October 1, 2021. DHS will accompany the announcement with a notice of the new deadline in the Federal Register in the coming days.

Separately, the United States Congress has also included language that would extend the deadline for REAL ID until September 30, 2021. The language was included as part of the enormous \$2 trillion supplemental appropriations package ([HR 748](#)) designed to mitigate the effects of the novel coronavirus (COVID-19). The

Motor Vehicle Industry Response to COVID-19 Pandemic

On March 11, 2020, the World Health Organization (WHO) [declared](#) COVID-19, a novel (new) coronavirus, to be a [global pandemic](#). This is a rapidly-evolving pandemic, and though early data suggested people above the age of 60 and/or with underlying medical conditions (such as diabetes, heart disease, or lung disease) were considered to be most at risk, [recent data](#) has shown 40% of hospitalized patients were between the ages of 20 and 54. By March 13, COVID-19 was declared a [national emergency](#) by President Donald Trump. FMCSA has [expanded](#) on the national emergency declaration in the United States to provide HOS relief for commercial vehicle drivers transporting emergency aid. The Centers for Disease Control (CDC) has encouraged many [preventative measures](#), including social distancing and cancelling events, but local and state government officials and public health departments, in consultation with federal officials, have been tasked with making decisions based on [local conditions](#). Many states have issued [stay at home orders](#). Lawmakers [asked](#) DHS to delay the federal REAL ID deadline, which was [granted](#) by the federal government. In response to the emerging situation, AAMVA has cancelled its 2020 Workshop & Law Institute, restricted staff business travel, and mandated a work from home period for all employees. The National Transportation Safety Board says two drivers, Tesla and lax regulation of new partially automated driving systems are to blame for a fatal 2019 crash in Florida involving a Tesla on Autopilot. The NTSB, in a report issued last Thursday, said the design of the Autopilot system contributed to the crash because it allowed the Tesla driver to avoid paying attention. Virginia Dept. of Motor Vehicles Warns of Fake Website

The Virginia Department of Motor Vehicles issued a warning on Friday about scam websites that are imitating the DMV's website. Indiana Bans Holding Cellphone While Driving Starting July 1

Drivers will be banned from using handheld cellphones on Indiana roads starting in July under legislation Gov. Eric Holcomb has signed into law to combat distracted driving. Holcomb signed the measure Wednesday, making Indiana the 22nd state to prohibit drivers from holding or using a handheld mobile device while operating a moving vehicle. 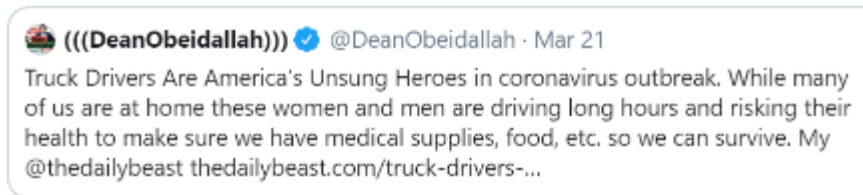

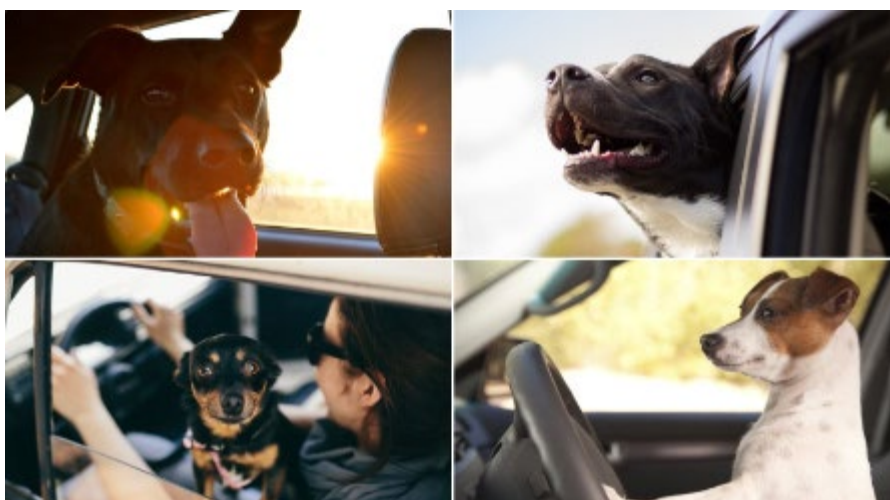
