Major Drop in Traffic Fatalities in Alabama This Year

According to the Foundation For Advancing Alcohol Responsibility, there were 268 alcohol-related traffic fatalities in 2017. More than 10,000 in the country that same year. 27 people under the age of 21 died in the same year on Alabama roads, slightly more than 1,000 in the U.S. And the number of teenagers arrested for driving under the influence was 42 in 2017 in Alabama. In that same year more than 5,000 in the same age bracket in the U.S...But there is encouraging news. As of today, state troopers in Alabama have worked 41 fewer traffic fatalities compared to this time last year, a nod to motorists paying more attention and not taking chances with their phones or drinking, according to the Alabama Law Enforcement Agency. New Amendment May Reinstate Driver's Licenses for More Than Half a Million Virginians, Governor Says (Virginia)

Virginia Gov. Ralph Northam announced an amendment to the state's budget on Monday eliminating the suspension of driver's licenses for those who cannot pay court fines and costs. The amendment would restore driving privileges for more than 627,000 Virginians with suspended licenses. 'The practice of suspending a person's driver's license for nonpayment of court fines and costs is inequitable. It's past time we end it,' Northam said. 'A driver's license is critical to daily life, including a person's ability to maintain a job. Eliminating a process that envelops hundreds of thousands of Virginians in a counterproductive cycle is not only fair, it's also the right thing to do.' [Read the article at wusa9.com](#).

New Amendment Would Ban Hand-Held Cellphone Use on All Virginia Roads

Virginia Gov. Ralph Northam is trying to revive an effort to ban motorists from holding cellphones while driving. Northam announced Tuesday he's adding a proposed amendment to legislation that would bar drivers from holding a cellphone while driving in a highway work zone. The governor's amendment would broaden the ban to all roads in Virginia. 'The time has come for the Commonwealth to implement an effective and fair law to combat distracted driving,' Northam said in a news release. 'Too many families have lost loved ones as a result of a driver paying more attention to their phone than to their surroundings. Duke Study Says 1 in 7 NC Drivers Currently Have License Suspended (North Carolina)

A Duke University study released Monday says about one out of seven people in North Carolina who can drive currently have their license suspended. Duke Law researchers found there are 1.2 million people in the state with active driver's license suspensions for non-driving related reasons...According to Duke's study, 827,000 suspensions are for failure to appear in court, 263,000 of them are for failure to comply with orders to pay fines and fees and 135,000 suspensions are because of both. Illinois Begins Issuing Driver's Licenses That Comply With Federal Real ID Law

After years of delays, all Illinois residents will be able to get new driver's licenses and state IDs beginning Monday that comply with post-9/11 federal requirements aimed at making identification cards more secure. Secretary of State Jesse White's office began issuing cards that comply with the federal Real ID Act in January, and they will be available at all 138 driver services facilities statewide by Monday. Indiana Driver's License Bill That Would Have Made Gender Changes Harder Is Shelved

The Indiana House ditched a bill that would have made it more challenging for transgender and nonbinary Hoosiers to change their driver's licenses or state ID cards. Senate Bill 182, which was quietly removed from the House's Tuesday calendar, would have required Hoosiers to present a birth certificate that corresponds to their new gender if they want to change it on a state-issued ID, instead of just the currently accepted physician's note. Manitoba Orders Training for Rookie Truckers

Manitoba truckers must soon have at least 121.5 hours of training to their credit before hitting the highways. The province will mandate the training for first-time commercial truck drivers beginning on Sept. 1, following the lead of Alberta and Saskatchewan. The Cincinnati Bengals beat the Cleveland Browns, the Cincinnati Reds beat the Cleveland Indians, and FC Cincinnati edged out the Columbus Crew. But when it comes to specialty license plates, Ohio is still Buckeye Nation. Ohio State University collected the most money of any Ohio entity from specialty license plates' donations last year: \$585,800 from 22,055 license plates. That total is for three designs, including 923 license plates for the Ohio State University Marching Band plate. Ohio

Mark an X — Gender No Longer Required on Saskatchewan Driver's Licence

Saskatchewan Government Insurance says in a statement that anyone who doesn't identify as male or female can choose to mark an X on the documents. Spokeswoman Penny McCune says the Crown-owned company is committed to being inclusive and realizes some people don't want to be forced to identify as either male or female. Alberta, Ontario, and Newfoundland and Labrador already offer their residents the option not to specify gender on their licences. Distracted Driving Habit Is Proving Tough for Americans to Break

Nearly eight in 10 consumers talk on the phone while driving and more than 30 percent admit to having been in a near-miss crash because they were distracted. Also, although distracted driving poses potential liability risks for companies, many expect employees to remain connected and do little to discourage such behaviors behind the wheel. Travelers Companies announced these and other results of its 2019 Travelers Risk Index, which surveyed more than 2,000 consumers and executives about distracted driving and the reasons behind it. Domino's Adds In-Vehicle Ordering for Customers

In case customers need another way to order Domino's Pizza, the chain will roll out in-car touchscreen ordering for new model vehicles that support the technology by the end of the year. Domino's is working with Xevo, an in-vehicle commerce platform for connected cars — featuring smart sensors and other advanced technologies — to preload software enabling customers to order pizza while in the car. The new feature will be automatically configured onto millions of cars with the Xevo platform installed, according to the companies. In a recent market study, Xevo found that of 3,260 drivers surveyed, 71 percent said they would prefer their vehicles infotainment system to allow them to order food ahead of time for pickup. Driverless Car Learns to Perform High-Speed Turns Without Crashing

A self-driving car has learned to make high-speed turns without spinning out. The skill could come in useful during emergency manoeuvres. J. Christian Gerdes and his colleagues at Stanford University in California used a type of artificial intelligence algorithm called a neural network, which is loosely based on the neural networks in our brains, to create the self-driving system. They trained the neural network on data from more than 200,000 motion samples taken from test drives on a variety of surfaces, including on a mix of snow and ice at a track near the Arctic circle. Study Backs Beliefs About Older Drivers

Keeping their car keys matters more to rural older drivers than to urban and suburban drivers who live closer to stores and doctors and have access to public transportation. Europe Will Require Carmakers to Install Speed Limiters From 2022

New cars sold in Europe from 2022 will have to be fitted with systems to limit their speed. Under new safety rules agreed by the European Union, all new vehicles are required to have 'intelligent speed assistance' systems as standard equipment. The EU rules don't mandate specific technology for the systems, which can be temporarily overridden by the driver. Some carmakers have already developed ways of using GPS or cameras to detect posted speed limits and make sure vehicles adhere to them. [Read the article at cnn.com](#).

States With Texting While Driving Bans Have Fewer ER Visits After Car Crashes: Study

Texting and driving is among one of the highest causes for distracted driving. And, according to the American Journal of Public Health, it's also responsible for a large number of motor vehicle crashes. A new study published earlier this year shows that states enacting a ban on texting while driving show a four-percent reduction in the number of emergency room visits post-accident. The study examines data from 16 different U.S. states from 2007 to 2014, looking at the number of states which call for a ban on texting while driving and the number of motor vehicle-related hospitalizations. A two-day proactive law enforcement operation designed to locate victims of human trafficking resulted in 8 misdemeanor and 2 felony charges.
