

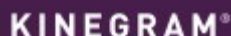

Saskatchewan RCMP Busy During Road Safety Week

Amazon Curtails Some Service, Highways Closed, as Protests Impact Freight and Driver Safety

As protests over the death of George Floyd continued around the country on Saturday and into this morning, many turning violent, their impact is now spreading to the freight world. Amazon (NASDAQ: AMZN) announced that it is recalling drivers and adjusting routes in several cities affected by protests, including Chicago, Los Angeles and Portland, Oregon. Self-Driving Cars May Prevent Only a Third of Road Crashes, Study Shows

Reducing traffic deaths caused by driver error has been the main promise of self-driving-car technology, a promise industry has used to justify billions of dollars of investment and the rush to get automated technologies on the road without much regulation. Study Finds Small Cars Offer Less Protection and Have the Highest Death Rates in Crashes

Insurance Institute for Highway Safety has released the results of a new study that says small cars are some of the deadliest vehicles on the road. According to the organization, "15 of the 20 models with the highest death rates for model year 2017" were either small cars or minicars. The study also found that minicars had the highest fatality rate as there were 82 deaths for per "million registered vehicle years." That contrasts with "very large" SUVs which were the safest with a fatality rate of just 15 per million. [Read more at carscoops.com](#).

NTSB Calls on NHTSA to Adopt New Limo Regulations

The National Transportation Safety Board is calling on the National Highway Traffic Safety Administration to adopt limo safety reforms in the wake of the Schoharie limo crash. The letter from the NTSB includes the recommendations of lap and shoulder belts for all passenger seats on vehicles that were modified to be limousines. They also recommend seat belts for all passengers on buses that weigh anywhere from 10,000 to 26,000 pounds. [Read more at news10.com](#).

House Democrats rolled out a \$500 billion draft transportation infrastructure bill on June 3 that includes significant investments in the country's aging roads and bridges. As Iowans start driving back to workplaces during some of summer's hottest days, remember the risk of heatstroke if children are left unattended in vehicles. Please use this checklist to return to your travel routine. #LookBeforeULock

LOOK BEFORE YOU LOCK!

Create a routine! Check off the tasks you will try today.

-  Make it a routine to open the back door of your car every time you park.
-  If you are driving a child, after you correctly buckle them in a car seat or booster seat—**put something you need at your destination in the back seat** so you will open the back door: a cellphone, employee badge, handbag, or other item you need to keep with you...even your **left shoe!**
-  Ask your babysitter or child care provider to call you if your child hasn't arrived as scheduled.
-  Keep a stuffed animal in the child's car seat. Place it on the front passenger seat as a reminder when the child is in the back seat.
-  Set the alarm on your cell phone or computer calendar as a reminder to drop your child off at child care. Remember to make the alarm song/sound different from all other alert sounds on your device.
-  If you have a **change in routine**, such as your spouse or parent dropping your child off at child care instead of you, make sure you and the other person communicate to confirm the drop-off was made.
-  Consider technology that alerts drivers to check the back seat. (Vehicle and child restraint manufacturers have been working on various evolving alert systems and some technologies are available now!)
