Too Little Air, Too Much Cement: CVSA Roadcheck 2019 Uncovers Violations (Maryland)

About 130 officers and inspectors with the Maryland State Police and representatives of eight other agencies were on hand to conduct inspections and help out. This year's Roadcheck emphasis was on steering and suspension systems, said Capt. Josh Barnes of the Maryland State Police...During the enforcement effort, inspectors primarily were conducting North American Standard Level I Inspections, a 37-step procedure that includes an examination of driver operating requirements and vehicle mechanical fitness. However, inspectors said they may opt to conduct the Level II Walk-Around Driver/Vehicle Inspection, Level III Driver/Credential/Administrative Inspection or Level V Vehicle-Only Inspection, CVSA said. Real ID driver's licenses are coming to New Jersey this month, but questions from drivers about the new, more secure license are being asked now. It is perhaps one of the most controversial issues that the New York State Assembly is looking to tackle before the end of its session: should undocumented immigrants be allowed to get a NYS driver's license? Those opposed say people who came into the country illegally should not be eligible for a license unless they apply for citizenship. Clerks in all eight (8) Western New York Counties have voiced opposition to the idea because it would allow undocumented immigrants to use foreign documents to prove their identity - something the clerks fear will make it hard to spot fake documents. On the other side, supporters say the bill is needed to help undocumented immigrant families who cannot drive children to school or medical checkups without fear of being deported. Age Requirement Drops from 21 to 18 for CDLs in Alabama

Last week, Gov. Kay Ivey signed a bill to lower the age requirement to get a commercial driver's license in Alabama and the change will go into effect in early 2020. The intention is to attract more people to the business of driving trucks. According to long-time truck driver, Justin Dean Faust, who is now a CDL instructor at Trenholm State Community College, the new law allowing drivers to obtain licenses at an earlier age might help younger drivers so they wouldn't mind the sacrifice of making a good living on the road away from family, so early in their careers. House Transportation Committee Votes to Pass Act Focused on Rideshare Safety (North Carolina)

A bill to make rideshares safer in North Carolina is one step closer to becoming law. The House Transportation Committee voted to pass the Passenger Protection Act Tuesday morning. The bill would put regulations in place to ensure passengers are getting in the right car. These regulations would include requiring rideshare drivers to display the vehicle's license plate number in a location visible from the front of the vehicle, and requiring drivers to display signage or emblems while active on the rideshare platform. The Tennessee Highway Patrol reported that 410 people have died on TN roads this year. The number has increased to 38 more than this time last year. With a Red Light Camera Ban in Place, Do You Have to Pay an Outstanding Ticket? (Texas)

Gov. Greg Abbott signed House Bill 1631 into law Saturday, banning red light cameras in Texas. But many drivers still have questions about why some cities may be allowed to operate the cameras and whether drivers really have to pay the tickets. The new ban allows local authorities to operate red light camera systems under the terms of vendor contracts -- until those contracts expire. The law also eliminates the enforcement mechanism, saying the Texas Department of Motor Vehicles or a county assessor-collector can not refuse to register a vehicle because of an unpaid red light camera violation. Process to Reinstate Suspended Driver's Licenses to Begin July 1 (Virginia)

The Virginia Department of Motor Vehicles (DMV) is preparing to send letters to Virginians whose driving privileges are suspended for failure to pay court fines and costs to advise them of any specific requirements for obtaining their driver's licenses. The state budget includes a provision that prohibits courts from suspending driving privileges solely for failure to pay court fines and costs, effective July 1. Also beginning July 1, any Virginian whose driver's license has been suspended for that single reason will have his or her driving privileges restored, and the associated reinstatement fee waived. The change only affects a person's ability to get his or her driver's license. It does not eliminate the requirement to pay the underlying court costs and fines. [Read the article at yourgv.com.](#)

Like most big criminal cases, the odometer fraud ring that Missouri Highway Patrol Cpl. Nate Bradley recently busted started with one victim. 'A gentleman came to my shop here in Lee's Summit and he said, "Hey, I bought this car, and I think I got swindled,'" Bradley recalls. 'So I started looking into it and sure enough, he got swindled.' Over a five-year investigation, Bradley eventually uncovered 48 victims of a rollback scheme around Kansas City, according to a grand jury indictment in a case that was recently unsealed. New Driver's License Office Opening (Nebraska)

If your license renewal is due, there is a new location to pay attention to. A new driver licensing office is opening in North Omaha, replacing the office currently located at N 30th Street. The new office will continue to roll out of the streamlined licensing process, already in place at the Metro South location in Bellevue. This new setup will create a more efficient experience for customers, who will no longer need to line up again to pay county treasurer staff separately. One other change customers will notice is the transition of the north office to become an express station, meaning customers can complete all standard license renewal practices at this location, however the express location will not offer written or driving tests. Since 1908, the state of Ohio has required drivers to install a front license plate on their vehicles. Starting next year, that is all about to change. Governor Mike DeWine recently signed a new transportation bill for the state of Ohio. Among the provisions in this bill was the elimination of a front license plate requirement for the state. Currently, Ohio is one of 36 states that require a front license plate. Despite being a part of this majority, Ohio is surrounded by states that do not require a front license plate. WisDOT Catches Fraudulently Ordered Driver's Licenses of 71 Dane County Residents (Wisconsin)

Duplicate driver's licenses were fraudulently ordered for 71 Dane County residents, indicating that those residents' identifying information had been compromised, officials with the state Department of Transportation said Friday. Several callers told the DOT that they received duplicate driver's licenses in the mail that they had not ordered, Department of Motor Vehicles administrator Kristina Boardman said. Officials discovered that the driver's licenses had been ordered through the DMV's online system, Boardman said, which requires knowledge of a person's Social Security number, driver's license number and date of birth. State Senate Passes Bill Waiving Title Transfer Fee for Deceased Spouses (Wisconsin)

A bill is working its way through the corridors of the State Capitol that would waive the \$69 title transfer fee when removing the name of a deceased spouse's name from a motor vehicle title. The state Senate unanimously passed S.B. 162 on Wednesday; it now goes to the Assembly where it is expected to pass. 'When a spouse dies, it is an emotionally and financially difficult time for the surviving loved ones,' state Sen. Van Wanggaard, R-Racine said in a statement. 'While it may seem like a small fee, this fee can be an obstacle to moving through the grieving process. This bill helps individuals heal when they are ready to do so.' Service Alberta Enacts Section 75.1 of the Operator Licencing and Vehicle Control Regulation, Alta Regulation 320/2002

The Registrar of Motor Vehicle Services (Service Alberta) has enacted section 75.1 of the Operator Licencing and Vehicle Control Regulation, Alta Regulation 320/2002. This is to assist residents under evacuation order from the communities of High Level, parts of Mackenzie County south of High Level and Dene Tha' First Nation communities of Bushe River, Meander River and Chateh who may encounter difficulties renewing their driver's licence, identification card and vehicle registration(s). Hey, Idahoans! Don't Want to Wait in Line at the DMV? You May Not Have to Anymore (Idaho)

Lyft Completes 50,000 Self-Driving Rides in Las Vegas (Nevada)

Last week, the ridesharing service Lyft announced that the company had completed more than 50,000 autonomous for Lyft passengers. The company's effort is in partnership with Aptiv, and with the recent milestone, the two make for the largest commercial self-driving program in the nation. The program was launched in 2018 after the Consumer Electronics Show, or CES, with Aptiv's Autonomous Mobility platform was introduced to Lyft's ride-hailing app. A fleet of 30 self-driving vehicles took to the streets, accomplishing 5,000 rides by August 2018 using Aptiv's three different types of sensors to maneuver. FMCSA Launches Interstate Pilot Program for Drivers Ages 18-20 with Military Experience

The Federal Motor Carrier Safety Administration is now accepting applications for a pilot program that would allow people between the ages of 18 and 20 who possess the U.S. military equivalent of a commercial driver license to operate trucks in interstate commerce. FMCSA announced the pilot program's launch June 3. The program, slated to run for up to three years, is meant to help veterans and reservists find jobs in the trucking industry. Current federal law does not allow this age group to drive Class 8 commercial motor vehicles across state lines. [Read the article at ttnews.com.](#)

GM Adds Trickier Roads to Its Semi-Autonomous Driving System

General Motors is adding 70,000 miles (113,000 kilometers) of roads across the U.S. and Canada to the area where its Cadillac Super Cruise semi-autonomous driving system can run, including some with cross traffic similar to those that have confused Tesla's Autopilot system. Currently the GM system can travel on 130,000 miles (210,000 kilometers) of limited-access highways that don't have crossing traffic or intersections. It will expand to 200,000 miles (320,000 kilometers) in the fourth quarter of this year. GM says it has tested the system and it should spot cross traffic and brake. Music experts have long pointed out similarities between the conventions of heavy metal and the music of Bach, Beethoven and other classical masters, and it turns out both genres correlate to opposite but similarly dangerous behaviors. Whether you like head banging or pretending to conduct an orchestra, you shouldn't do it while driving. A U.K. road safety study conducted by IAM Roadsmart and Auto Express magazine examined the effects of different types of music on driver behavior. Listening to heavy metal while driving distracted the test subject and made his driving more irregular, but listening to classical caused him to be overly relaxed and too slow, the study found. [June 6th] is National Secure Your Load Day! An important reminder every year about the dangers of driving on roads with loose items in the back of your vehicle. This causes major accidents nationwide every year. According to the National Highway Traffic Safety Administration, in 2016, there were 683 deaths, 19,663 injuries and 90,266 incidents related to unsecured loads. In just three years, between 2011 and 2014 there were more than 200,000 crashes, resulting in 39,000 injuries and 500 deaths. Unsecured loads cause harmful road debris as well...Founder Robin Abel spoke to the importance of everyone taking the time to check their loads before they get on the road. She said, 'We put on our seat belts and fasten our children in car seats so why is it that we think it's OK to leave anything loose in the bed of our trucks and risk endangering others on the road? 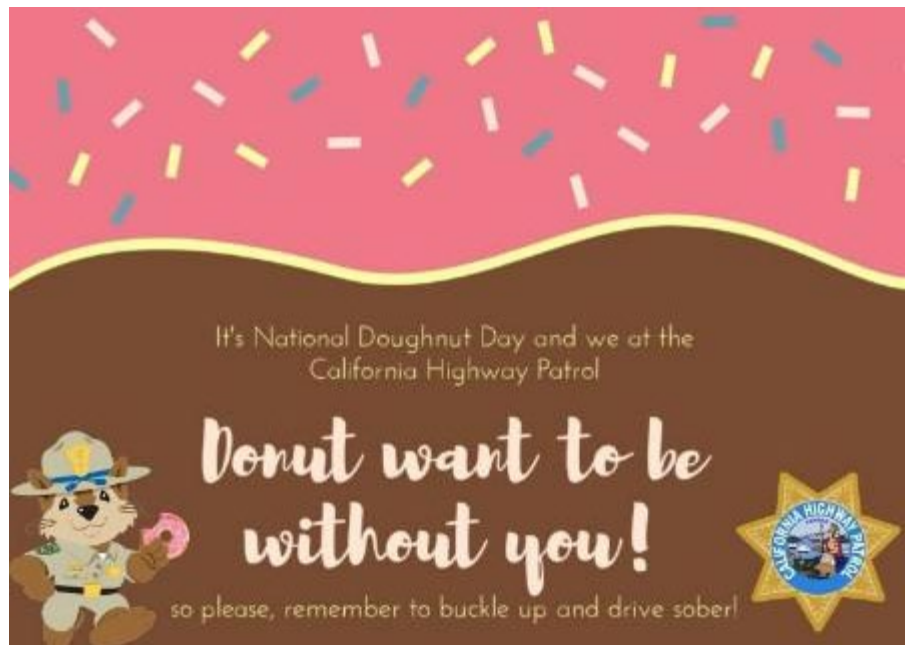
