Fee for Colorado Drivers Licenses to Increase 10% by July 1

The fight against impaired driving in Saskatchewan is making progress. Just look at the numbers from 2019, which show that fatalities and injuries dropped to the lowest numbers ever. SGI shone their traffic safety spotlight on impaired driving in May, and police officers around the province kept an especially close eye out for those drivers. Jumio, AAMVA Reveal Biometric Deduplication Service to Detect Synthetic Identity Fraud

Jumio has launched a new service for checking the data on submitted driver's license to detect synthetic identity fraud. This solution was created in partnership with the American Association of Motor Vehicle Administrators (AAMVA) for facial biometric deduplication. The new suite of data-driven services includes address validation, proof of residence, and a Face Lookup service that flags potentially fraudulent activity when the same face is used in multiple verification attempts. Digital Driver's License Service Now Available in Korea Through Identity Authentication App PASS

SK Telecom, KT and LG Uplus, have jointly launched a digital driver's license service on PASS, an identity authentication app provided by the three mobile carriers. Launched in July 2018, PASS currently has 30 million subscribers and is mainly used for authentication in mobile financial transactions. Developed jointly by the three mobile carriers, the Korean National Police Agency and the Road Traffic Authority (KoRoad), the digital driver's license marks the first case where a digital version of an official identification is used as a legally acceptable form of identity verification.
