#### Cue the Stampede to the DMV as Delaware Offers New Low-Digit Plate Numbers

Several five-digit license plates will be up for grabs in Delaware starting July 9, the DMV announced this week. Low-digit tags are coveted as a sign of prestige in Delaware, sometimes fetching thousands at auction. Typically the lower the number, the more valuable it is, with some five-digit tags currently on sale online for \$750 to \$2,000. The state also sometimes makes low-digit tags available to the public. Starting July 9, a limited number of five-digit license plates will be available at the Delaware City, Dover, Wilmington and Georgetown DMV locations on a first-come, first-served basis. #### MVA: More Than Half of Maryland Drivers Now Compliant With Real ID Rules

More than half of Maryland's 5 million licensed drivers are now fully compliant with federal REAL ID requirements as the October 2020 deadline looms, officials said Tuesday. By the deadline, all Marylanders will need a REAL ID-compliant driver's license or identification card to board a plane or enter a federal facility. With millions still yet to obtain a REAL ID, the Maryland Department of Transportation Motor Vehicle Administration has extended branch hours and opened additional offices to handle the influx of customers. ## New Slow-Moving Vehicle Law Takes Effect Wednesday (New York)

Drivers and operators of slow-moving vehicles...be prepared for a new law that takes effect Wednesday. Under the new law, farm, construction and other machinery designed to operate at speeds greater than 25 mph and less than 40 mph will now be required to display a Speed Identification Symbol and the 'slow-moving vehicle triangle.' The SIS must indicate the vehicle's top speed. Operators will also be required to carry documentation from the manufacturer indicating the maximum speed the vehicle was designed for. ## Gender X on Driver's Licences and Identification Cards (Nova Scotia)

In July 2019, the Nova Scotia Registry of Motor Vehicles (RMV) will introduce additional options in the Sex/Sexe field of both Driver's Licences and Nova Scotia Identification Cards. These changes are occurring to keep Nova Scotia in line with modern identification standards as well as to ensure inclusiveness of all Nova Scotians. Up until now, the only options for sex/sexe were 'M' – Male and 'F' – Female. Moving forward an additional non-binary option of 'X' - Gender Unspecified will be available. All individuals will have one of these three options identified in the RMV database. Individuals will be permitted to self-disclose as 'X' – Gender Unspecified, however proof of gender must be submitted to update to sex/sexe value between 'M' – Male and 'F' – Female. All individuals will also have the option to have the sex/sexe field appear blank on their Driver's Licence or Identification Card. [Read the article here.](#)

## SAAQ Rejects 1,500 Personalized Licence Plates for Being Vulgar, Racist (Quebec)

More than 30,000 Quebec motorists have applied for a personalized licence plate since the option to get one became available last summer, earning the province about \$3 million in the process. So far, 28,500 personalized plates have been issued, and Quebec's automobile insurance board (SAAQ) considers this a notable achievement...But not all applications are accepted. The SAAQ refused more than 1,500 requests for plates determined to be vulgar or racist. Vaillancourt said a committee of employees meets weekly to analyze the applications in all languages and reject those that are considered inappropriate. [Read the article at cbc.ca.](#)

### Starsky Robotics Tests First Unmanned Autonomous Truck on Public Highway in Florida (With Video)

Starsky Robotics tested its fully unmanned autonomous truck on a 9.4-mile stretch of public highway on the Florida Turnpike on June 16. The company had previously been testing its self-driving technology on private roads. 'We are now the only autonomous company that's testing trucks without having people in the cabs on public roads with the motoring public,' Stefan Seltz-Axmacher told FreightWaves. ## **Police Officers Pose as Construction Workers to Catch Distracted Drivers (Georgia)**

Police officers in Georgia dressed up as construction workers to catch people using their phones behind the wheel. Three Marietta police officers went undercover and stood at an intersection last Wednesday to nab distracted drivers. They watched for motorists who were violating the state's hands-free law, not wearing their seat belts or both, the Marietta Journal reported. When the undercover cops spotted violators, they radioed the vehicle descriptions to uniformed officers waiting nearby, who then pulled over the drivers. ## **KY Starts Rollout of New Driver's Licenses on June 28 (Kentucky)**

Kentucky's new, more secure driver's licenses that will be Real ID compliant will begin on June 28...Residents will choose between standard and travel licenses. The travel license offers all of the benefits of a standard driver's credential, and it will be accepted at airport security checkpoints and military bases...Matt Henderson, commissioner of the Department of Vehicle Regulation, said starting in Franklin, Woodford and Hart allows the department to 'closely monitor the entire process and make any needed changes before cards roll out statewide.' ## **New Tag, Vehicle Registration Rules Begin July 1 (Oklahoma)**

Under a new state law that requires Oklahomans to keep their license plates when selling vehicles, car owners will need to carry proof of their registration in their vehicles as well. Senate Bill 1339, which goes into effect July 1, dictates that when a car is sold, the tag will stay with the original owner...'Starting July, if you sell a vehicle, remove the tag,' Oklahoma Tax Commission spokesperson Paula Ross said. 'The tag will now stay with the person, not the car. When motorists purchase a new car, they will take the tag from their old car and place it on the new one. This will assist law enforcement in tracking current vehicle owners as well as cut down on past owners receiving turnpike fines, parking tickets or other issues involving their old vehicle.' ## **Vanity License Plates in TN (Tennessee)**

Each year, the Tennessee Department of Revenue receives hundreds of submissions for vanity license plates. Our Local Consumer Alert team learned that the state agency rejects dozens of requests. Kelly Cortesi with the Tennessee Department of Revenue said state law prohibits the Department from issuing plates that are offensive or misleading. Citing state law, Cortesi said, 'Tennessee's Department of Revenue shall refuse to issue any combination of letters, numbers, or positions that may carry connotations offensive to good taste and decency or that are misleading.' ## **Nearly 1 Million Texans on Verge of Getting Driver's Licenses Back as of Sept. 1 (Texas)**

Nearly 1 million Texans will be able to get their driver's licenses back Sept. 1, when the state's driver responsibility program ends. The program was created to encourage people to drive better and raise money for trauma care but it ended up creating financial hardships for Texans convicted of traffic violations who had to pay fines and then annual surcharges to keep their licenses from being suspended. That could total thousands of dollars over three years, lawmakers say...The program ends Sept. 1, under House Bill 2048, which recently was signed into law by Gov. Greg Abbott. ## **Secretary White's Legislation Combating Texting While Driving Takes Effect July 1 (Illinois)**

Illinois Secretary of State Jesse White's legislative initiative strengthening the law on texting while driving takes effect July 1. The law cracks down on texting while driving by classifying first-time offenses as moving violations. Under the previous law, second and subsequent texting while driving offenses are treated as moving violations, while first offenses are treated as nonmoving violations. 'With the increased use of technological devices, distracted driving has become a serious problem on the roads of our state and throughout the nation,' said White. ## **Click It or Ticket Campaign Results in 8,100+ Traffic Stops, Nearly 3,000 Tickets (Michigan)**

The spring Click It or Ticket campaign in 38 Michigan counties led to 8,145 traffic stops and 2,930 citations for failure to buckle or put children in proper safety seats. The campaign took place from May 20 to June 2 involving 109 local police agencies, sheriff's office and the Michigan State Police. Besides the seat belt tickets, officers working on the Click It or Ticket campaign issued 693 speeding tickets, made 13 drunken driving arrests and arrested 45 people on outstanding warrants...'Thank you to all the law enforcement officers who are working hard to encourage seat belt use – every trip, every time,' said Michael L. Prince, director of the Michigan Office of Highway Safety Planning (OHSP). 'Motorists need to remember that buckling up is the easiest thing they can do to reduce traffic fatalities and injuries on Michigan roads. Our goal is to save lives, not write tickets.' ## **Campaign Aims to Reach All Minnesota Drivers With Info About New Hands-Free Law**

A new law requiring drivers to use phones in a hands-free mode goes into effect Aug. 1, and in the coming weeks Minnesotans can expect to hear a lot about it. ### All California DMV Offices Will Close for Half a Day of Real ID Training

California's Department of Motor Vehicles will close all of its offices for half a day on July 24 to train workers on the federally mandated Real ID program. ### Gov. Signs New Hawai'i Highway Safety Measures (Hawaii)

The Hawai'i Department of Transportation (HDOT) reports that the following bills passed in the 2019 Legislature have been signed into law by Gov. David Ige, according to a HDOT press release issued on June 26, 2019: Senate Bill 663 – Adds a new chapter to the Hawai'i Revised Statutes on Photo Red Light Imaging Detector Systems effective on July 1, 2050; directs the department of transportation to establish a red light running committee to review the act and present recommendations to the legislature. Senate Bill 98 – Clarifies that vehicles must stop for pedestrians when any part or extension of the pedestrian is beyond the curb or edges of a traversable roadway or when the pedestrian moves onto the roadway within an intersection or crosswalk...[Read the article at bigislandnow.com.](#)

### Hawaii to Become the Latest State to Offer 'Gender X' Option on Driver's Licenses for Non-Binary Individuals

F, M or X? A bill that will require all state-issued identification and driver's licenses in Hawaii to offer a non-binary gender option is poised to become law Wednesday. Democratic governor David Ige is expected to sign Bill HB1165 into law, which will let residents choose option X, if they don't identify as either male or female. ## 'Move Over' Law Expanding to Include Highway Crews (Idaho)

A law improving highway safety for tow trucks and other highway crews will take effect on July 1. The existing law from 2006 already gave protection to police by requiring motorists to move over for law-enforcement personnel operating with flashing lights. Now, drivers must also move over for other emergency responders to traffic incidents. This includes Idaho Transportation Department (ITD) workers and tow truck operators using flashing lights in a stationary position. ## 15th Annual Allstate America's Best Drivers Report® Ranks U.S. Cities with the Safest Drivers

Brownsville, Texas, has the safest drivers in America for the second year in a row, according to the 2019 Allstate America's Best Drivers Report®. Released in advance of July Fourth, the deadliest day on U.S. roads according to the Insurance Institute for Highway Safety, the 15th annual report aims to start a national dialogue around the critical issue of roadway safety, celebrating the top-ranked cities' drivers as an example for other communities. The America's Best Drivers Report ranks the 200 largest U.S. cities by collision frequency based on Allstate claims data to determine which have the safest drivers. For the first time, Allstate also tapped into its claims data to uncover the 'Risky Roads' with the most collisions in the bottom 15 cities to help those drivers be extra vigilant, while also advocating for infrastructure improvements. ## As Marijuana-Use Laws Spread, Drug Still Illegal for Truck Drivers

Last month, drug-testing firm Quest Diagnostics scientist Barry Sample had a serious warning for U.S. employers: Be on the lookout for marijuana use by your workers. It's on the rise. 'Our in-depth analysis shows that marijuana is not only present in our workforce, but use continues to increase,' said Sample, Quest's director of science and technology. 'As marijuana policy changes, and employers consider strategies to protect their employees, customers and general public, employers should weigh the risks that drug use, including marijuana, poses to their businesses.' Indeed, an analysis of 10 million drug tests Quest administered in 2018 concluded that every segment of overall workforce is increasingly flunking lab drug tests for marijuana. Also, Sample noted, attempts to cheat on drug tests are on the rise. Those tested include federal safety-sensitive transportation workers, which include truck drivers. ## FMCSA Proposes Rule to Add Flexibility to CDL Skills Testing

The Federal Motor Carrier Safety Administration has proposed a rule that would increase flexibility for the skills test process for those seeking a commercial driver

license. Current federal regulations do not permit a CDL skills instructor who is authorized by the state to administer a CDL skills test to perform both the instruction and the test for the same applicant. FMCSA's proposal, announced June 27, would eliminate that rule. Additionally, the proposal would give states the discretion to allow qualified third-party trainers to also conduct skills testing for the same person. [Read the article at tnews.com.](#)

## **Most Drivers Say Safety Tech Has Saved Them From Crashes**

Most drivers with advanced auto safety technologies in their cars say the features have helped keep them out of crashes, according to a new survey from Consumer Reports. About 57% of respondents said features like automatic emergency braking, blind spot warning and lane keeping assistance have helped prevent collisions. The responses covered about 72,000 vehicles with the features, according to the consumer advocacy group that publishes Consumer Reports magazine. Such safety systems use a variety of cameras and sensors to detect other vehicles, pedestrians and lane markings. They can warn drivers of an impending danger, such as a car in an adjacent lane, or even take action like braking automatically to avoid a collision or steering the vehicle back into its lane. 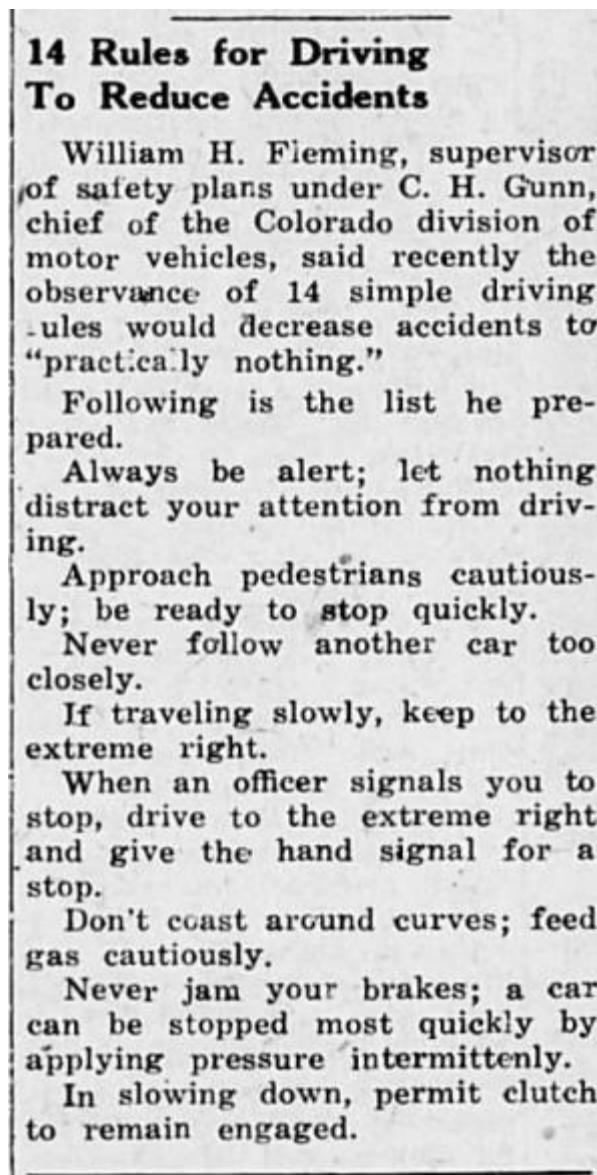

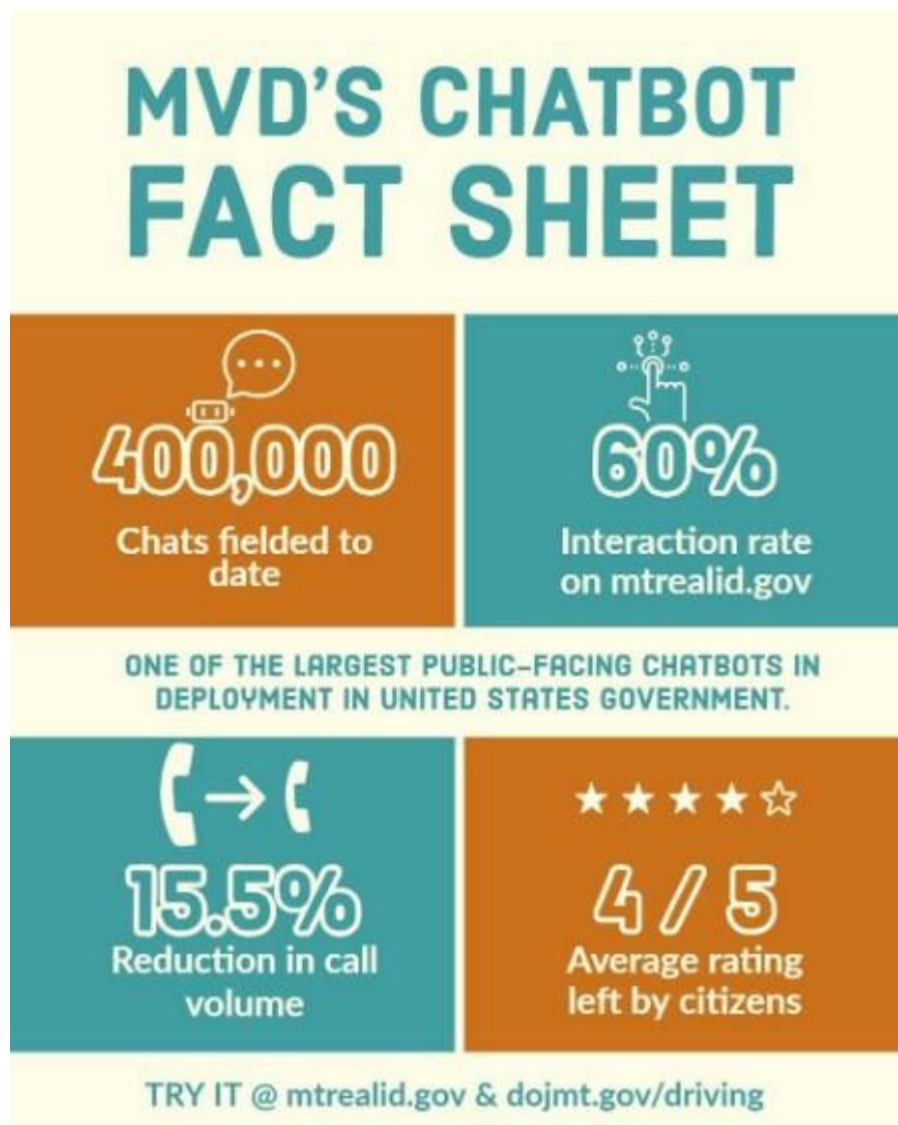
