**Maine**

The number of Connecticut vehicles registered in the state of Maine is growing. But the state of Connecticut has no idea how many of its residents are illegally registering their cars in other states. Department of Motor Vehicles Deputy Commissioner Antonio Guerrero said they have no central database that would track something like that. The Maine Secretary of State's office reports that 1,457 Connecticut residents have registered their cars up north where it only costs \$35. In Connecticut, it costs \$80 for two years plus another \$10 for the Clean Air Act. [Read more at the Middletown Press](#).

**Study Finds Older Drivers Have Lower Crash Rates (Massachusetts)**

Statistics tell us that the crash rate for older drivers is relatively low because most older drivers take precautions. According to the Massachusetts Registry of Motor Vehicles, many older drivers are able to self-determine if they should drive based on their mental and physical ability. As you get older, there is no age at which driving privileges are revoked, but here in Massachusetts, if you are 75 or older, you do have to renew your driver's license in person at an RMV Center to take an eye test. **Truck Driver Was on Drugs, Reaching for Drink at Time of Fatal New Hampshire Crash, Report Says**

Volodymyr Zhukovskyy was high on drugs and said he was reaching for a drink on the passenger side of his 2016 Dodge pickup truck when the vehicle crossed the highway's yellow center line and crashed into a group of a motorcyclists in New Hampshire in late June, according to a federal inspection report obtained by the Globe. The Federal Motor Carrier Safety Administration report provides the most detailed account to date — and the first accusation of Zhukovskyy's alleged intoxication — in the fiery collision that killed seven, injured three others, and led to a still-widening scandal at the Massachusetts Registry of Motor Vehicles, which had failed to revoke the 23-year-old's commercial driver's license prior to the crash. **PennDOT Plans Gender-neutral Option for Driver's Licenses**

Motorists who don't want to disclose their gender will be able to place an "X" on their driver's licenses instead of identifying themselves as male or female by the middle of 2020, a Department of Transportation spokeswoman said Tuesday. Thirteen other states, including neighboring Maryland, and most recently New Hampshire have rolled out plans to give residents a gender-neutral option on driver's licenses, according to the National Center for Transgender Equality, based in Washington, D.C. Teenagers in Kentucky are 140% more likely to die in a car crash than the average U.S. teen, according to a new report. Using data from the National Highway Traffic

Safety Administration, personal finance website ValuePenguin.com ranked Kentucky as the worst state in America for teen driver fatalities. The Bluegrass State has the highest average annual teen driver fatalities per 10,000 licensed drivers age 19 or younger, with 3.47 per year. From 2013 to 2017, Kentucky recorded 128 teen motorist fatalities. According to the report, teens in Kentucky are 16% more likely to die in a car crash than those in Mississippi — the second deadliest state, which averages three teen driver fatalities per year. ### **Mobile App Will Allow Drivers to Renew Oklahoma Vehicle Tags**

Oklahomans seeking to renew car, boat, motorcycle and trailer tags now can do it with a mobile phone app. Officials on Thursday announced those renewals can be done in a smartphone app called Gov2Go. It is available at the Apple App Store and Google Play Store. Bret Warren, president and general manager of Oklahoma Interactive, said the app is free, but the process will cost \$2 plus a merchant charge of 2.25% if a credit card is used. ### **Two Texas Truckers and a State Worker Sold Hundreds of Fake Commercial Driver's Licenses**

A federal grand jury indicted three Texas men – two truckers and a state worker – in connection with a scheme to sell commercial driver's licenses (CDLs) without the drivers having to take the required test, according to a report from the San Antonio Express-News. The indictment, which was handed down July 24 in a San Antonio court, said Alonzo Blackman, 62, a commercial driver's license examiner with the Texas Department of Public Safety (DPS), took bribes from two truckers – Marino Maury Diaz-Leon, 52, of San Antonio, and Fernando Guardado Vazquez, 40, of Austin. The number of fraudulent CDLs issued by Blackman was 215, of which 197 went to Cuban nationals, 11 to U.S. citizens, two to Mexican nationals, and one each to Dominican, Ethiopian, Iraqi, Puerto Rican and Ukrainian nationals. ### **TxDOT to Commit \$600 Million to Reducing Roadway Deaths**

Roughly two-thirds of a \$600 million down payment aimed at decreasing deaths along Texas highways will go to straightening roads, improving lighting and adding guardrails, under a plan being considered by state transportation officials. The Texas Department of Transportation proposes spending \$390 million, 65 percent of the total safety money set aside by the Texas Transportation Commission, to reduce incidents in which drivers veer from the roadway. Though causes vary, so-called "departure incidents" represent 41 percent of the serious injury and fatal injury crashes in Texas last year. [Read more in the Houston Chronicle.](#)

### **Virginia DMV Mobile Unit to Help Drivers Get Back**

## Licenses

Since July, 1, Virginia courts have stopped suspending driver's licenses for unpaid court costs or fines. And anyone whose license was suspended because of unpaid court costs or fines will be able to drive again. The DMV will remove the suspension for failure to pay court costs and fines from one's record, and that person will not have to pay a reinstatement fee to drive again. To help suspended drivers get their licenses back (and to help anyone else with Department of Motor Vehicles business), the DMV is adding mobile units to bring its services to people who can't get to a DMV office. In Danville, the DMV mobile unit will be at Virginia Legal Aid Society (519 Main St.) from 10 a.m. to 3 p.m. on Thursday. Anyone with pending DMV business is welcome to visit. ## Virginia DMV Explores Adding 'Electric Scooters' as Category on Crash Reports to Better Track Accidents

Virginia Beach [has Bird](#). Norfolk [has Lime](#). With new contracts between electric scooter companies and local municipalities, the number of electric scooters in Hampton Roads is rising... Virginia DMV reports seven crashes involving injuries, electric scooters and a motor vehicle in 2018 and five so far in 2019. DMV spokeswoman Brandy Brubaker wrote that these numbers "are much lower than electric scooter-related injuries that a police department or hospital might be reporting that include the sorts of incidents" the department doesn't track. This contributes to the overall uncertainty of the total number of electric scooter accidents across Virginia. As electric scooters begin to spread throughout the commonwealth, Virginia DMV says it is now "considering adding electric scooters as a box that officers could check on the crash report." Brubaker wrote that electric scooters are "an emerging issue, particularly in cities." [Read more on 13 News Now.](#)

## Heart-wrenching Ads Put Focus on Crash Victims in Road Safety Campaign (Illinois)

The TV ad shows a plump baby girl, giggling and cooing as she gets a bath. The baby is the daughter of Dennis Beard, an Illinois construction worker. Beard died in 2012 at age 38 in a vehicle crash while he was striping a downstate road, leaving behind three children. It is one of several heartbreaking ads running on television, digital billboards, ballpark Jumbotrons and social media as part of the Illinois Department of Transportation's "Life or Death" campaign. The goal of the ads is to show the human consequences of unsafe driving on Illinois roads, where more than 1,000 people die every year, including pedestrians, drivers and passengers. Under the new law, drivers who hold their phone behind the wheel or otherwise swipe, type, scroll or view content on their cellphones will be subject to tickets and fines. ### **ICBC Ready to Offer 'Fitbit for Cars' Pilot to 7,000 Youth to Improve Driving**

ICBC has teamed up with an IT company and is ready to go ahead with a study aimed at finding out whether using in-car sensors can help make new drivers into safe drivers. Now ICBC and Octo Telematics are looking for 7,000 new B.C. drivers to sign up for the study. Half will be a control group. The other half will be equipped with sensors to monitor speeding, braking and distracted driving, and their cellphones will be sent regular feedback on how to improve their driving. ### **Former DMV Employee Accessed Sacramento Database To Fraudulently Provide Class A Driver Licenses (California)**

Former DMV employee Kari Scattaglia, 40, of Sylmar, was sentenced to two years and eight months in prison for fraudulently providing people with Class A commercial driver licenses, announced U.S. Attorney McGregor W. Scott. Scattaglia, formerly of the Arleta DMV, and former Winnetka DMV employee co-defendant Lisa Terraciano, 52, of North Hollywood, pleaded guilty on Nov. 3, 2017, to a conspiracy to commit identity fraud, to commit bribery, and to commit unauthorized access to a computer, according to the Department of Justice. In exchange for money, the two individuals

accessed the DMV's Sacramento database to alter applicants records to falsely show that they had passed the required tests. [Read more at CBS Sacramento.](#)

## **Automakers, Colorado Reach Deal on Zero-emission Vehicle Mandate**

Colorado and major automakers said on Monday they have reached a deal on the state's plan to adopt California's zero-emission vehicle (ZEV) requirements after earlier talks had ended without a deal. The state, which plans to join the California program starting in the 2023 model year, has agreed to allow automakers to earn credits for selling electric vehicles in the two model years prior and use other transitional credits available in other states. ## **Maui Adds New Traffic Safety Initiatives As Death Toll Increases (Hawaii)**

This year is already turning out to be a dangerous one for traffic on Maui. On Sunday, two people were killed in a car crash—bringing the total number of traffic related deaths on the island this year to 14. This time last year, there were only 10 traffic related deaths in Maui county. According to officials, the county averages 18 deaths from traffic crashes each year. The Maui Department of Public Works is trying to decrease the county's traffic-related death toll through various safety initiatives. ## **Aggressive Driving Campaign Begins in Idaho**

As people across Idaho enjoy the final weeks of summer, the Idaho Transportation Department (ITD) and law enforcement agencies are partnering to keep Idaho roads safe. More than 50 law enforcement agencies began putting more officers on the roads to look for aggressive drivers on July 26. This effort comes in the middle of the 100 Deadliest Days of Summer. ## **Teen Crashes in Oregon Tied to Lack of Driver Education**

The Oregon Department of Transportation says the data is shockingly clear; driver's education makes for safer drivers. In a 2018 study from ODOT, officials found that in 91% of crashes with a teen driver, the teen driver had not taken a drivers education course to get their license. "We always see better driving behavior," said Oregon DMV spokesman David House. "Fewer crashes, fewer citations, among teen drivers that go through drivers ed, and this lasts through adulthood." ## **Oregon DMV Headed to Trial in Ashland Woman's Death**

A jury is weeks away from deciding the state of Oregon's culpability for issuing a driver's license to a man with five prior drunken-driving convictions who killed a local 911 dispatcher in a wrong-way crash on Interstate 5 in 2014. Despite efforts earlier this month by the state of Oregon, a judge ruled the state will remain a defendant in William Greenstein's wrongful death lawsuit against Richard Webster Scott Jr., the driver who killed his wife, Karen Greenstein, and the agency that issued his wife's killer a driver's license. **ABOUT YNDRC**

Motor vehicle crashes are the leading cause of death and injury for all young people (ages 1 through 24). Young drivers in general are two to three times (2x-3x) more likely to experience a crash. In particular, during the first six months of licensure, young drivers are eight times (8x) more likely to be involved in a fatal crash than more experienced drivers. To address this problem, the YNDRC contains research, tools and strategies for young drivers, parents and educators to help reduce the crash risk of young drivers and to improve their safety, and the safety of other road users.
