Legislative Alert: NHTSA Issues Final Rule Permitting Electronic Odometer Disclosures

The National Highway Traffic Safety Administration (NHTSA) has announced a [final rule](#) establishing standards under which states may allow for odometer disclosures in an electronic format. The final rule fulfills a requirement in the Moving Ahead for Progress in the 21st Century Act of 2012 ([P.L. 112-141](#), Section 24111). With publication of the final rule, the former latitude of a state to pursue independent solutions via FAST Act authority ([P.L. 114-94](#), Section 24111) “ceases to be effective on the date the regulations become effective.” The final rule adds new requirements applying to electronic disclosures to ensure the secure creation and maintenance of records.

AAMVA emphasizes that NHTSA is amending the mileage disclosure exemption to vehicles that are 20 years old or older (from the previous 10). The final rule amends exemption rules in [49 CFR 580.17](#) such that a transferor or lessee must disclose odometer mileage for an expanded number of vehicles extending beyond the previous 10-year limitation as described in the new §580.17. **This portion of the rule affects all jurisdictions regardless of their electronic titling intentions and provides an implementation methodology to incrementally modify the exemption.** [Read more here.](#)

Florida is the deadliest state in the U.S. when it comes to intersection fatalities, according to a new report based on data from the National Highway Traffic Safety Administration. The study commissioned by AutoInsurance.org shows Florida accounting for 10.03 fatalities per 1,000 miles of road between 2010 and 2017. The next deadliest state was Hawaii with 6.71 fatalities..."Our findings suggest highway intersection deaths are common along much of America's East Coast but are most prevalent in Florida by far. Kentucky Halts County-By-County Real ID Rollout Amid Concerns

With an October 2020 deadline looming, Kentucky is scrapping its longstanding plan to let people get new airplane-friendly driver's licenses from their local circuit court clerk's offices. Instead, the Kentucky Transportation Cabinet wants to create regional locations across the state where drivers could apply for the Real ID licenses, cutting out the local offices where residents have gone for decades for their credentials. Having county offices oversee the Real IDs, which can be used next fall to board domestic flights, is "not a sustainable long-term model," Transportation Secretary Greg Thomas wrote in a Sept. 6 letter, a copy of which WDRB News obtained. Agency Seeks to Shorten Lines at Driver's License Offices (Mississippi)

The head of the Mississippi Department of Public Safety told lawmakers Friday that his agency is working to reduce long waiting times at driver's license offices. Commissioner Marshall Fisher said the department has increased the starting salaries for driver's license examiners from \$21,000 to \$25,000 and is hiring more people to fill the jobs. The department has also started a "wait anywhere" test project, letting people go online to schedule appointments for driver's license testing at six offices — two each in the northern, central and southern parts of the state. Oklahoma Mobile Driver's License Program Moves Into High Gear

Add the Oklahoma mobile driver's license to the list of pioneering state-issued IDs. According to reports from local media, the state is beta testing its own mobile driver's license program, with hopes that a full program can be rolled out this fall, perhaps in October. Oklahoma is home to some 4 million people, of whom about 3 million are of driving age, according to U.S. Census and other estimates. Soon your driver's license or state identification card could be in the palm of your hand – but instead of a plastic card, now on your mobile device. A QR code consists of black and white squares used for storing information that can be read either by the camera or on a smartphone. Rene Strid recalls her bizarre visit to the DMV as something she never thought possible. "I was in the twilight zone and it was probably one of the worst car-buying experiences that I've experienced." Buying a used car can be a daunting experience for a variety of reasons...DMV Compliance and Enforcement Administrator Joseph (JD) Decker says his office gets about four stolen cars a week. When their system flags a car as stolen, he explains, "We get notified immediately because now it's essentially a felony stop for us. We have a stolen vehicle outside and we want to identify the person who brought the vehicle in--they could be a suspect or they could be a victim. There's a 50/50 chance. Brake Safety Week Underway for Commercial Fleets

The annual Brake Safety Week led by the Commercial Vehicle Safety Alliance (CVSA) kicked off on Sept. 15 and runs through Sept 21. For the duration of the initiative, enforcement officials will conduct roadside safety inspections on commercial motor vehicles throughout the U.S. and Canada. Electric Car Owners Could Choose Which Fake Sounds Their Cars Make Under New Proposal

The federal government is requiring automakers to include artificial motor sounds in

electric and hybrid cars when traveling at low speeds to alert pedestrians, but it wants to give vehicle owners the ability to choose which sounds they use. In a notice of proposed rule-making, the US National Highway Traffic Safety Administration says drivers should be able to “select the sound they prefer from the set of sounds installed in the vehicle.” But NHTSA is also seeking feedback about whether it should limit the number of fake sounds that manufacturers should be allowed to install. New Study Ranks Most + Least Dangerous Songs for Driving

A new study suggests rock can be both the safest and most dangerous music to listen to while driving, depending on the song's dynamics. Of the 10 songs tested by South China University of Technology, Green Day's "American Idiot" was the most hazardous, while Led Zeppelin's "Stairway to Heaven" was the most safe. This study used a total of 20 drivers and 60 driving simulation tests. "The association between in-vehicle music listening, physiological and psychological response, and driving performance" was studied, measuring "perceived mental workload, standard deviation of speed, and frequency of lane crossing." Thousands of Drivers Tagged for Speeding During Blitz

Canadian and U.S. enforcement teams handed out 17,556 speed-related citations during this year's Operation Safe Driver Week, in a blitz that targeted the drivers of commercial and passenger vehicles alike. Every 32 seconds in 2017, one child under the age of 13 in a passenger vehicle was involved in a crash. 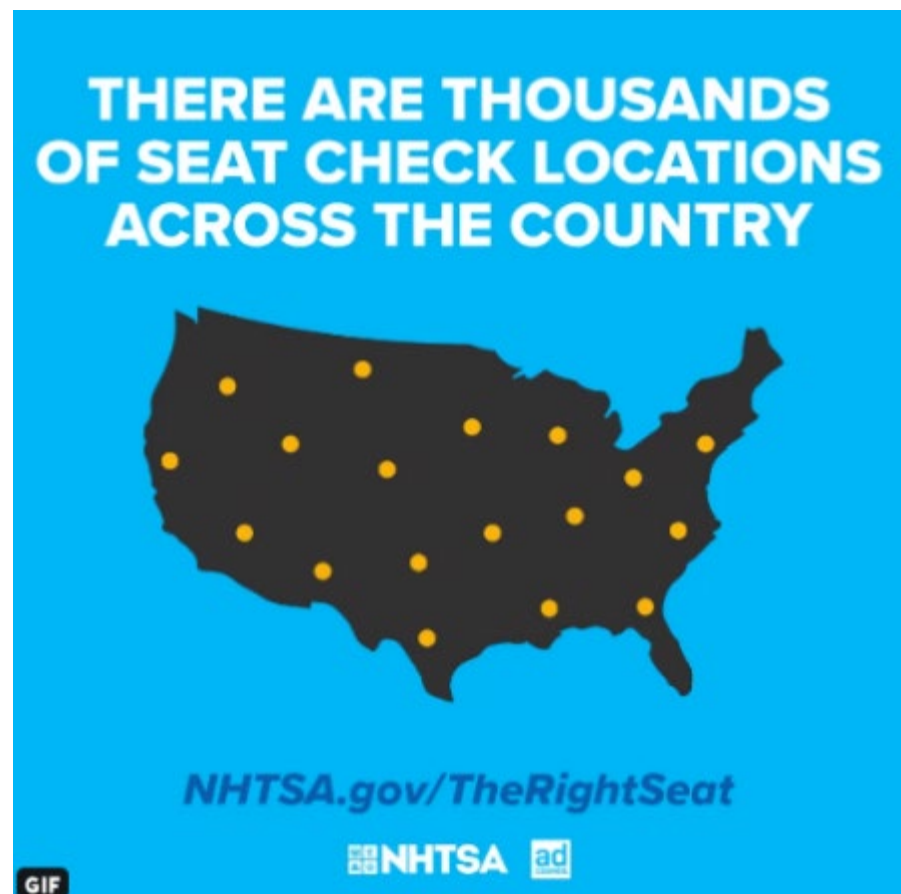

Another car seat tip!

The chest clip should be even with the child's armpits. If in the wrong place, the child is at risk of being ejected during a crash.

The clip is often moved when getting the child out, so check the clip's position every time you buckle up!
