## Customs Officers Intercept Record Number of Stolen Vehicles at Port of Wilmington (Delaware)

U.S. Customs and Border Protection (CBP) officers seized a stolen 2018 Cadillac Escalade, valued at more than \$57,000 at the Port of Wilmington, Del, September 25...This recovery was one of a record 16 stolen vehicles that CBP officers at the Port of Wilmington seized during fiscal year 2019, which ended on September 30. The combined value of the stolen vehicles is \$454,007, also a CBP Port record...Officers discovered that the Escalade's visible vehicle identification number (VIN) belonged to a 2018 Mercedes Benz and detained the vehicle for a thorough examination. ## MDOT MVA Updates Systems for New DUI and DWI Laws (Maryland)

The Maryland Department of Transportation Motor Vehicle Administration (MDOT MVA) said it was updating its systems and programs to support new laws related to highway safety that are taking effect this month. Among these are tougher DUI and DWI laws for those found guilty of driving under the influence, as well as harsher sentences for those found guilty of human trafficking...The law took effect October 1. Now, DUI and DWI offenders will see increased fines, as well as more jail time for repeat offenders. **DOJ Asks for More Time to Review Undocumented Immigrant Driver's License Law (New York)**

The U.S. Department of Justice says it needs time to weigh in on a legal challenge to a new state law that gives undocumented immigrants access to driver's licenses in New York. Federal prosecutors asked a judge for more time to consider their position on a lawsuit brought by several upstate county clerks that says the new law violates U.S. labor and immigration laws. Welcome to Pineway Boulevard, a charming suburban street complete with a tree for every bungalow, a parkette for every school and, for most of last week, signs on each block warning drivers to slow down. It was a test of a temporary measure to combat what residents say has been a plague of speeding drivers using the North York street to avoid Toronto's Don Valley Parkway for years...The approval process for permanent traffic-calming measures is lengthy, and requires support from residents, including a community meeting, and in some circumstances, a petition. Ms. Carroll said that despite concern from the community, it has been difficult to gather support for something permanent. "The pop-up has gotten people's attention," she said. **PA Ranks Third for Chance of Deer-Car Collisions, According to New Study (Pennsylvania)**

Pay attention behind the wheel. If you live in Pennsylvania, you have a 1 in 52 chance of hitting a deer while driving. According to State Farm's annual study, the Keystone State ranks third for the likelihood of deer-vehicle collisions, behind West Virginia and Montana. Nationwide, there were over 1.9 million animal collision insurance claims in the U.S. between July 1, 2018 and June 30, 2019. And how do I order the breast research license plate? A: This is a very timely question as October is Breast Cancer Awareness Month and the state's reissuance program is slated to begin in June 2020. Only "wave" plates will be replaced with a new state plate when the program begins, and this will be done upon registration renewal. The Alabama Department of Revenue (DOR) Oct. 1 issued a memorandum concerning the Rebuilt Alabama Act for excise tax purposes. The act provides an additional registration fee for battery and plug-in hybrid electric vehicles operated on the state's public highways. The additional fee is effective beginning Jan. 1, 2020. Beginning Jan. 1, 2020, the Uniform Motor Vehicle Valuation Manual will include a fuel type for all vehicles listed in its database. The DOR provided the list of fuel types. ### Operation Green Light: Florida Counties Allowing Drivers to Pay Overdue Fines Without Surcharges

In a statewide initiative, 60 Florida counties are participating in Operation Green Light to get drivers safely and legally back on the road. For one day this year, state clerks will waive the collection fee surcharges when drivers are paying their overdue tickets to get their licenses reinstated..."The legislature passed a new law addressing the issue of folks driving without a license and this is an effort to get them legal again, get them back in the system, get them back to work and to take some financial burden off of them," said John Crawford, Nassau County Clerk of Court and Comptroller. ### DDS Lands \$83k Grant for Motorcycle Safety Program (Georgia)

The Department of Driver Services' (DDS) Georgia Motorcycle Safety Program (GSMP) has received a grant for \$83,464.00 from the Governor's Office of Highway Safety (GOHS). This funding will be used to help reduce motorcycle fatalities, increase driver awareness of motorcycles, and educate motorcycle riders about safety initiatives. According to the Insurance Information Institute, motorcyclists are 28 times more likely to die in a crash than an automobile rider. "The grant from the GOHS enables the Georgia Motorcycle Safety Program (GMSP) to continue making the roads safer for riders and non-riders," said DDS Commissioner Spencer R. Moore. ### Kentucky Urges Motorists to Buckle Up, Put Phones Down

Highway safety officials in Kentucky have launched a campaign aimed at preventing traffic crashes by encouraging motorists to buckle up and put down their phones. The Kentucky Office of Highway Safety launched the "Buckle Up Phone Down" campaign Monday. It features videos, radio spots, digital advertising and a new dedicated website to promote the initiative. ### LSU Gets \$773,500 to Study Commercial Vehicle Crash Causes (Louisiana)

A Louisiana university has a \$773,500 federal grant to use streaming traffic camera video to study commercial motor vehicle crashes. The lead researcher is Professor Helmut Schneider at Louisiana State University's Center for Analytics & Research in Transportation Safety. A news release Friday said Schneider and Supratik (soo-PRAH-tik) Mukhopadhyay (moo-koh-PAH-tay) in LSU's Division of Computer Science will use advanced analytics and artificial intelligence to analyze video as it comes in from multiple cameras. ### New State License Plate, Rideshare Signage Regulations Go Into Effect (North Carolina)

As the state budget standoff enters a new month, the N.C. General Assembly continues to work as its long session, which started in January, continues. New laws have passed and gone into effect, such as new license plate requirements,

rideshare regulations and an incentive for volunteer firefighters. Starting in July 2020, Session Law 2019-227 requires motorists to obtain a new license plate every seven years, per the language of the bill signed into law on Sept. 27. ### **Uber Hosts Town Hall on Self-Driving Cars (Texas)**

Starting in November, Uber says two of its autonomous SUV's will begin mapping downtown Dallas streets in the first step toward launching self-driving cars in North Texas. At a town hall event at Uber's new corporate offices in Deep Ellum, Uber Advanced Technologies Group CEO Eric Meyhofer explained the mapping would take several months before the company commits to launching an autonomous service in Dallas...Dallas would be the fourth city where the ride-sharing company would offer self-driving technology. ### **Automated Voter Registration Coming (West Virginia)**

Multiagency coordination is underway between lawmakers, the Division of Motor Vehicles, secretary of state, county clerks and the governor to provide West Virginia with new systems to implement "opt-out" Automated Voter Registration...West Virginia operates an "opt-in" program, wherein eligible citizens are asked if they want to register to vote while at the DMV. These voter registration files are sent by the DMV daily to all county clerks through an automated process. Under the pending "opt-out" program, voters are not asked if they want to register to vote; they're registered automatically at the DMV, unless they are ineligible or affirmatively decline. A 16-year-old Jenison High School student was able to get a Michigan driving law changed after testifying in front of the state Senate. Two bills were brought before and eventually approved by the Michigan Senate and House of Representatives this summer. Senate Bill 192 introduced a waiver to the 10 hours of night driving needed for drivers under 18 to get a Michigan graduated driver's license if the driver has an impairment that disallows them from driving at night anyway. House Bill 285 (HB 285) in Ohio looks to create a permanent program to help people with suspended licenses, reduce or forgive reinstatement fees. But for a short time, beginning Oct. 17, people can use the extended pilot program to get help. "Of the 1,000,000 people with suspended licenses, if we believe they've just stopped driving we're not being realistic," State Representative Dave Greenspan said who is co-sponsoring the bill. ## **Enlisting Truckers to Fight Human Trafficking (Wisconsin)**

Truck drivers in Wisconsin would be enlisted to help fight human trafficking under a bill proposed in the state legislature. Senate Bill 25, introduced in February and recently approved by a committee, would require commercial motor vehicle driver education classes include information on how to recognize and prevent human trafficking. Proponents said the measure makes sense because human trafficking regularly occurs along highways and at truck stops and rest areas, places populated primarily—and sometimes only—by truck drivers. ### FMCSA Administrator Ray Martinez to Leave Post

Federal Motor Carrier Safety Administrator Ray Martinez will be leaving his position at the end of October. The U.S. Department of Transportation, which encompasses FMCSA, announced Oct. 10 that Martinez will be leaving his post, although he will remain with DOT. In his new position, he will oversee redevelopment construction taking place at the agency's John A. Volpe National Transportation Systems Center in Cambridge, Mass. The Volpe Center, a hub for transportation experts, focuses on infrastructure and innovation. FMCSA Chief Counsel Jim Mullen will move into the deputy administrator role at the agency. ### U.S. Travel Launches Initiative to Get Travelers Real ID Deadline-Ready

Almost three out of four Americans are unprepared for the October 2020 deadline for full implementation of REAL ID, and millions could be prevented from boarding a plane due to lack of required identification, according to a U.S. Travel Association-commissioned study. ### ATA Establishes Policies on Recreational Marijuana Laws

American Trucking Associations executives have approved a set of policies meant to help the industry safely operate amid the growing legalization of recreational marijuana. ATA announced the policies at the group's annual Management Conference & Exhibition on Oct. 8. The policies were developed by ATA's newly formed Controlled Substances, Driver Health and Wellness Subcommittee... Specifically, the new policies call for the government to uphold the right of employers to test for marijuana, support lifting federal restrictions on marijuana research and encourage more research on the drug's impact on impairment, support the development of oral fluid testing and impairment standards and call for a marijuana victims compensation fund. ## **Cars With High-Tech Safety Systems Are Still Really Bad at Not Running People Over**

For years now, automakers have been stuffing their cars with loads of advanced technology on the promise that all these sensors and software will make for a less deadly driving experience. But new research suggests that new technology isn't doing enough to keep pedestrians safe. The American Automobile Association (AAA) conducted a series of tests using vehicles with automatic emergency braking and pedestrian detection alerts on a closed course with dummy pedestrians. And what they found was highly upsetting. The vehicles struck the dummy pedestrians that were crossing the road 60 percent of the time — and this was in daylight hours at speeds of 20 mph. 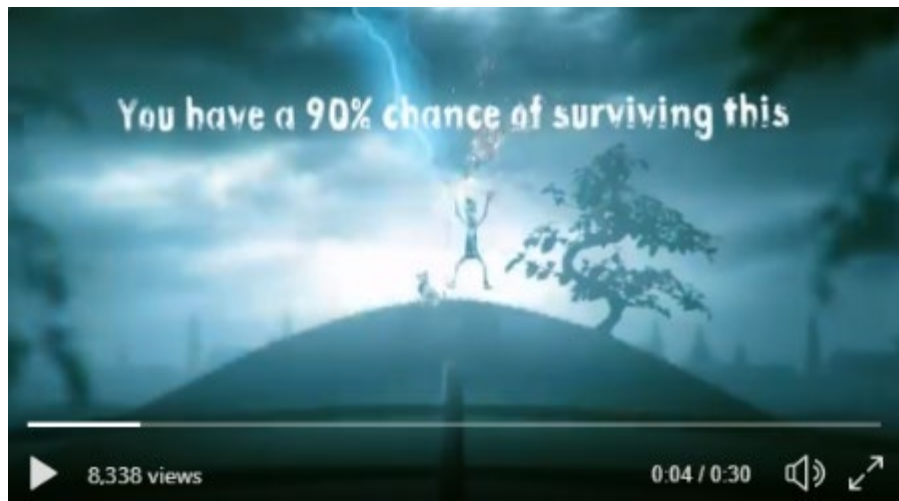
