Here Are Some of the 6,000 Words Maryland Won't Let You Put on Your Vanity License Plate

The Maryland Motor Vehicle Administration has expanded its list of rejected vanity license plates to more than 6,000. The "Objectionable Plates List" is a decades-long collection of vulgar words and other terms Marylanders have unsuccessfully tried to put on their bumpers. The list contains words and phrases rejected by the MVA due to scatological or sexual meaning; curse words, epithets or obscenities; deceptive or fraudulent meanings; references to illegal acts; or messages about a race, ethnicity, religion, sexual orientation or disability. New, Updated Changes for NJ Driver's Licenses, Real ID Wait Times (New Jersey)

The Motor Vehicle Commission is making weekly changes and updates to its driver's license and REAL ID system now that wait times are reportedly as long as three months. The agency also has more than twice as many places to get one – 17 – than it had a month ago. The MVC said it is expanding its services every week and adding appointments as quickly as the "next day" – not three months, according to William Connolly, a spokesman for the agency. NJ Transportation Officials Working on Plan to Reduce Fatal Crashes (New Jersey)

Data from the New Jersey State Police shows that 563 passengers, bicyclists and pedestrians were killed on New Jersey roads last year, compared to 624 in 2017, a drop of more than 9%. "That's good that we're trending in the right direction but there's always things that we can do to make roads safer," said Steve Schapiro, the spokesman for the state Department of Transportation, which is developing a plan to keep people safe on the roads. The department is holding 2020 Jersey Strategic Highway Safety Plan summits with stakeholders in transportation, law enforcement, emergency response and healthcare. [Read more at nj1015.com](#).

Green Light Law to Take Effect (New York)

A state law allowing undocumented immigrants to apply for driver's licenses is set to take effect Dec. 14, and local clerks are warning they may be ill-prepared to handle the influx of applicants. The new law, known as the Green Light Law, will make New York one of 13 states to allow unauthorized immigrants to obtain a driver's license. Tennessee Ahead of National Average Obtaining Real ID

Tennessee’s 4.7 million valid driver’s license and state-issued identification card holders have listened to the call to have their cards replaced with a new identification card called REAL ID...“Getting a Real ID in Tennessee is optional,” according to Wesley Moster, director of communications for the Tennessee Department of Safety and Homeland Security. “With that said, Tennessee is an outlier compared to other states in terms of how many people are getting their Real ID. The national average of people getting a Real ID is 27%. Currently Tennessee is seeing roughly 33% of their residents getting a Real ID.” As of Nov. 21, the department had issued 278,943 Real IDs. For Texans Tired of Waiting for Hours at Driver’s License Centers, Here’s What the State Plans to Do (Texas)

Beginning next year, the Department of Public Safety plans to roll out an appointment system that would likely prevent the struggles Kesinger and other Texans have faced. Under that new system, people could set up appointments up to six months in advance. It is one of several changes the department is making as it tries to cut down the wait times. In September, the state Legislature provided the department with about \$200 million to cut wait times, and officials have hired 563 new staffers to fill vacancies at driver’s license centers across Texas. DMV statistics show over 900,000 people have already obtained their REAL-ID’s as of December 2019. Officials say that there are still over 1.7 million people who have not...DMV officials say not to wait until later to apply, as right now is the best time to do it. “The best time to come to the Virginia DMV is the middle of the week, middle of the morning, middle of the afternoon,” said Richard Holcomb, Commissioner of the Virginia Department of Motor Vehicles. “REAL-ID is about a 17-minute transaction, about five minutes longer than a regular transaction, but being prepared is going to get you through a lot quicker.” [Read more at wric.com.](#)

Missouri Unveils New Temporary License Plates to Fight Fraud

Missouri is cracking down on drivers who use fake temporary license plates with new holographic, temporary tags. The word "void" will appear if anyone tries to copy them. Ohio Announces Virtual Tests for Student Drivers

It won't count for or against them, but new drivers in Ohio will now take virtual tests to provide feedback on their driving skills. The state recently announced the launch

of "Ready, Set, Drive!" It's a new program to administer free virtual driving assessments in Ohio's 57 driver exam locations, along with many driver training schools in the state. "The free virtual driving systems will scientifically examine student driver preparedness and help Ohio make data-driven improvements to its overall driver education curriculum," a release from Ohio Gov. Wisconsin Seeing Fewer Traffic Deaths in 2019

State transportation officials are hailing a drop in deaths on Wisconsin roads. The latest figures from the state Department of Transportation show the 495 fatalities as of Nov. 17. That's down from 521 at the same point in 2018. The number of fatal crashes is also down. There were 463 as of Nov. 17, down from 467 through the same period in 2018...But Jonathan Adkins, executive director of the Governors Highway Safety Association, said the goal remains getting the total number of deaths on the roads to zero. Wisconsin Hybrid Owners Are Noticing a New State Fee. Will They Pay More Overall Than Gas-Only Vehicle Owners? It Depends.

Wisconsin has technically had a \$75 surcharge on gas-electric hybrids — as well as a \$100 fee for electric vehicles — for two years, but the fee on hybrids was not initially collected by the state Department of Transportation because the law was written in a way that made it difficult to determine which cars qualified. That was changed this year, in the state's biennial budget, to make the law clearer and more enforceable. The amended language removed the distinction between a plug-in hybrid, which starts in electric mode before switching on its gas engine, and a conventional hybrid, like Dutton's Prius. Wait Times Are Dropping at the California DMV. How You Can Avoid Getting Stuck in Line

Newly released data from the California Department of Motor Vehicles show the state making a huge dent in the wait times customers are experiencing across the state. In a report sent to state lawmakers last month, the DMV showed it has cut delays nearly in half. As of September, customers across the state without an appointment waited an average of 38 minutes, which represents a 48 percent decrease from the average time of 73 minutes customers experienced at the same time last year. According to the DMV, the drop stems from a substantial decline in the amount of time customers spend waiting just to get a number, as well as "increased staffing and season shifts in customer volume." CDOT Observes Older Driver Safety Awareness Week (Colorado)

The Colorado Department of Transportation announced it is observing Older Driver

Safety Awareness Week Dec. 2-6 to help keep seniors safe on the road. The goal of the program is to promote the importance of mobility and transportation for older adults and to ensure they can remain active in their communities without transportation becoming a barrier to their mobility, a press release stated. In 2018, 129 drivers older than 65 were involved in fatal crashes. In that same year 74 older drivers died in car crashes. If you've ever dreamed of presenting your phone at the airport or at a bar as proof of ID, the wait may soon be over. Phones using the premium Snapdragon 865 chip will

be able to tap into a new feature coming to Android R, the next version of Google's operating system for phones. CBP Seizes Thousands of Fake IDs Headed From China to New York

Federal officers recently intercepted nearly 3,000 fake driver's licenses and more than 3,100 blank card stocks used to make counterfeit licenses in Kentucky, according to US Customs and Border Protection (CBP). The IDs were heading from China to various locations in New York, the federal agency said, adding that the fake driver's licenses were seized at an Express Consignment Operations hub in Louisville, Ky. Pedestrian fatalities have increased nationwide over the last decade, and distracted driving has become a concern intensified by the growing popularity of smartphones and increasingly large display screens on dashboards, among other factors. As a result, vehicle manufacturers are developing automated features such as pedestrian detection sensors and auto-braking systems to assist drivers when they might not have the opportunity to react before an oncoming collision. But the effectiveness of these systems is still in question. According to a AAA study released in October, crash-prevention failure rates among certain car models featuring this technology were "alarming," the auto club said in an Oct. 3 news release. Self-Driving Cars Are Predicting Driving Personalities

In a recent study by a team of researchers at MIT, self-driving cars are being programmed to identify the social personalities of other drivers in an effort to predict their future actions and drive safer on roads. It's already been made evident that autonomous vehicles lack social awareness. Drivers around a car are regarded as obstacles rather than human beings, which can hinder the automata's ability to identify motivations and intentions, potential signifiers to future actions. Because of this, self-driving cars often cause bottlenecks at four-way stops and other intersections, perhaps explaining why the majority of traffic accidents involve them getting rear-ended by impatient drivers. Federal Government Assesses Digital Options to Ease Real ID Rollout

Less than a year away from the official rollout of the federal Real ID standard, about two-thirds of Americans don't have a compliant license. But federal officials are looking into digital alternatives to ensure travelers can keep flying...Obtaining a Real ID-compliant license requires an in-person trip to the Department of Motor Vehicles. At least for now. The Washington Post reported last week that DHS is considering options that would allow people to apply for a Real ID online. "The department is interested in ideas and technologies that could allow applicants to submit their

These Are the 10 Most Stolen Vehicles in Canada

Owners of Ford F-series pickup trucks should take extra care to lock their vehicles because it appears they're a primary target for thieves. Once again, Ford F250 and F350 trucks from the 2000s topped the Insurance Bureau of Canada's annual ranking of the most stolen vehicles in Canada. In 2019, Ford pickup trucks took up eight of the top 10 spots on the list with the 2007 Ford F-350 claiming the unenviable title of most stolen vehicle for the year. It's unsurprising news for anyone who has been following the IBC's annual ranking, which is based on insurance claims data collected from "nearly all" automobile insurance companies in Canada. Australia Rolls out Tech to Catch People Using Cell Phones While Driving

Authorities in New South Wales, Australia, have launched a detection camera program that aims to stop people illegally using their smartphone while driving. During the first three months of the new system, which went live Sunday, drivers caught by the technology will be sent a warning letter. After this, offenders will be given five demerit points and a fine of 344 Australian dollars, which equates to around \$235. The fine rises to 457 Australian dollars in school zones.
