NMVTIS Performance Management Concept (PMC) Pilot

AAMVA has initiated the NMVTIS Performance Management Concept (PMC) pilot. The purpose of the PMC is to develop tools to support ongoing monitoring by AAMVA and the states to support optimum state performance in the system. The PMC pilot consists of three reports and an interactive map. The reports will monitor NMVTIS to capture unexpected activities that can potentially result in inaccurate data or fraudulent activities. The interactive map enables easy visual access to a subset of a state's profile information. This pilot will last 12 months and include participation from nine states: Iowa, Mississippi, Missouri, New Hampshire, Pennsylvania, South Dakota, Texas, Virginia and Wyoming. Upon Completion of the pilot, AAMVA will make a determination on expanding these tools to all jurisdictions participating in NMVTIS.

TSA, State Officials Urge Travelers to Get Real ID-Compliant Driver's Licenses (Maine)

The Transportation Security Administration and the Maine Secretary of State's Office are urging travelers to get Real ID-compliant driver's licenses or identification cards sooner rather than later..."People aren't necessarily thinking about the paperwork they need, and especially since the actual hard deadline isn't until next October, the more times that we can get this into people's heads, and remind them that it's not a one-hour process," Maine Secretary of State Matt Dunlap said. New Jersey Driver's License Bill Passes Assembly Panel

Undocumented New Jersey residents are inching closer to being able to be issued driver's licenses from the state. On Monday, the state's Assembly Judiciary agreed in a 4-2 vote to pass the bill to a full Assembly vote after hearing testimony from advocates and immigrants...After state lawmakers introduced the latest version of the bill last year, activists pressured lawmakers to move it forward and staged protests in its favor across the state. The bill allows for two types of licenses, one compliant with the federal Real ID Act, which would allow users to board flights, and one that would be issued to immigrants without legal status and others who lack documentation. Higher Number of Fatalities on Manitoba Roadways in 2019

Manitoba roadways have been more deadly in 2019 compared to last year, according to Manitoba Public Insurance. New numbers from MPI show the number of deaths in collisions in Manitoba has just climbed over the total for 2018. As of Dec. 7, 73 people have died in crashes this year, while 2018 saw 71 fatalities. MPI says at least 15 deaths were caused by drivers impaired by alcohol or drugs — down from 2018's total number of 30 impaired driving fatalities. Speed was also factor in 16 of the deaths, while another 16 involved people not wearing seatbelts, including the death of a child who was also not restrained. Montana Residents Urged to Plan Ahead to Get Real ID

Currently, available appointments to get a REAL ID in Bozeman are about 10 weeks out. Helena appointments aren't available for nine weeks, while the next appointments in Billings are eight weeks away, according to the scheduling website. The crowded appointment calendars in those cities are due in part to staffing shortages, said Anastasia Burton, a spokeswoman for the Department of Justice, which includes the Motor Vehicle Division. State officials are considering opening driver's license exam stations outside of regular business hours and on weekends to deal with the backlog, said Sarah Garcia, administrator of the Motor Vehicle Division. DMV to Drop Fee for No-Photo Disabled Parking Placards (Oregon)

A new Oregon law will remove a costly Catch 22 for people who need a disabled parking placard but are medically unable to go to a DMV office. While disabled placards are provided at no charge, DMV is currently required to charge customers for no-photo identification cards if they are medically unable to visit a DMV office. The current fee for a parking ID card is \$44.50 for a customer's first card, \$40.50 for renewals and \$39.50 for replacements. Starting in January 2020, DMV will issue these no-photo ID cards free of charge. [Read more at ktvz.com.](#)

New Law Will Allow Plate Transfers From Totaled, Altered Vehicles as of January 2020 (Oregon)

If DMV receives notice that your car is totaled or substantially altered after Jan. 1, 2020, you will be able to keep the plates and registration on the vehicle or transfer them to another vehicle. House Bill 2576 passed by the 2019 Legislature changed requirements to transfer plates and registrations for some vehicles. Here is what the new law does: Requires tow companies to allow the registered owner to remove their plates from a vehicle after it has been towed. Allows you to transfer your plates and registration when a salvage title has been issued to your totaled or substantially altered vehicle. Allows you to keep the plates and registration on, or transfer them from, a vehicle that is totaled or substantially altered, or is recovered after a theft, as long as a salvage title has not been issued. Allows an approved customer-provided special interest plate to be transferred from one vehicle to another qualifying vehicle. [Read more at content.govdelivery.com.](#)

State Officials to Discuss Gas Tax, Congestion Tolling, Self-Driving Cars (Washington)

Will Washington drivers pay a gas tax, or will they to pay per mile? The State Transportation Commission plans to make a recommendation early next week, as well as leading discussions on a variety of other topics. As vehicles become more fuel-efficient or drivers switch to electric cars, gas taxes for the state are predicted to drop by nearly half...Also presenting to the commission will be John Niles, the co-author of a book on autonomous vehicles. He will lead a discussion over the concept (and relative safety) of 50 percent or more of privately owned vehicles shifting to fully-automated driving. While no concrete rulings or decisions will be made, it will be a larger part of the commission's "ongoing examination" of the viability of self-driving

20 Women File Lawsuit Against Lyft, Contending They Were Sexually Assaulted by Drivers

Twenty women have filed a lawsuit against Lyft, alleging that ride-share drivers raped or sexually assaulted them. In the lawsuit, filed Wednesday in San Francisco Superior Court, the victims contend that the company ignored their complaints and does little to ensure safety of female passengers. Lyft is based in San Francisco...The women are seeking unspecified financial damages and for Lyft to install cameras in drivers' vehicles, CBS News reported. A Lyft spokesperson said the company is continuing to improve safety for its passengers. FMCSA Extends Drug Clearinghouse Deadline for State Agencies

Federal regulators made final a proposed rule delaying the compliance deadline for the Drug & Alcohol Clearinghouse by three years for state motor vehicle agencies. Instead of being required to access the new database on Jan. 6, 2020, state agencies will have until Jan. 6, 2023, to comply with the rule to give states more time ensure IT systems can securely tap into the system, according to the Federal Motor Carrier Safety Administration (FMCSA). The 2020 deadline remains in effect for drivers and carriers...The three-year extension came at the request of the American Association of Motor Vehicle Administrators (AAMVA), which raised five major questions. DHS Not Planning to Extend Real ID Deadline

Following up on something we wrote about [Wednesday](#): After House Democrats said an extension could be necessary for requiring travelers to use REAL ID, DHS quashed the notion. A Silicon Valley startup has completed what appears to be the first commercial freight cross-country trip by an autonomous truck, which finished a 2,800-mile-run from Tulare, California to Quakertown, Pennsylvania for Land O'Lakes in under three days. The trip was smooth like butter, 40,000 pounds of it. Plus.ai, a 3-year-old company in Cupertino, announced the milestone Tuesday. U.S. Telecoms, Traffic Agencies Clash on Plan to Use

Some Auto Safety Spectrum for Wi-Fi

The U.S. telecommunications regulator voted on Thursday to advance a plan to split a key spectrum block set aside for auto safety to accommodate the burgeoning number of wireless devices, but the Transportation Secretary warned that doing so could lead to "thousands more deaths" in traffic accidents. The Federal Communications Commission voted Thursday 5-0 to advance the plan to split a block of the 5.9 GHz spectrum band that was reserved in 1999 for automakers to develop technology to allow vehicles to talk to each other, but has so far gone largely unused. 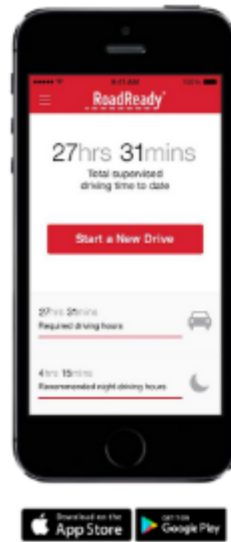
