He joined police chiefs, sheriffs, and public safety commissioners and officials—and a senior corporate security manager—in a 21-member delegation of senior law enforcement officials from Georgia, Alabama and Tennessee who participated in the Georgia International Law Enforcement Exchange's (GILEE) 26th annual peer-to-peer training program in partnership with Israel. ## Three New Traffic Laws in Effect to Improve California Roads

The first law in effect applies to private carriers like church buses and employee shuttles. The DMV and CHP will oversee a program to ensure private carriers are operating in a safe manner and maintain adequate insurance coverage. The second requires children between the ages of 8 to 15 on a bus to wear a seatbelt or be properly restrained. The last law in effect prohibits Uber or Lyft drivers with a blood alcohol concentration of 0.04 or higher from transporting passengers. However, proper safeguards must be established immediately by federal regulators to govern the testing and deployment of AVs and ensure public safety.
