(NMVTIS) are supported under the NCS infrastructure.

In order to improve performance and provide more flexibility, the NCS is being reengineered. AAMVA is currently proceeding to the final setup tasks before final production cutover. The cutover to the new system is planned for the weekend of July 4th. While, there is no planned outage to accommodate this upgrade, the system may experience few intermittent interruptions during the weekend. Associated hardware installations will be done on Sunday, June 19th during the regular maintenance window of 2am – 5am ET and should not affect regular production activities.

The migration of states/subscribers from the process will be done in multiple phases. States/subscribers identified to be in the first batch on the July 4th weekend will experience a brief interruption. Other NCS subscribers should not be impacted. The remaining states will be migrated to the new NCS on a periodic basis during scheduled maintenance windows with no anticipated interruptions. AAMVA will work with all NCS subscribers to determine the schedule of their migration.

2013 Ontario Road Safety Annual Report (ORSAR)

The Ontario Ministry of Transportation (MTO) is pleased to announce the release of the 2013 Ontario Road Safety Annual Report (ORSAR). This year's report is available at www.ontario.ca/ORSAR. The combined efforts of MTO's road safety partners, public education, enforcement, and road safety initiatives are making our roads safer for all Ontarians. In 2013, the provincial fatality rate per 10,000 licensed drivers was 0.54, the second lowest rate in North America, and the second lowest rate ever recorded in Ontario. This marks the 15th consecutive year that Ontario has had the lowest or second-lowest fatality rate among all jurisdictions in North America.
