## FEDERAL NEWS

### FHWA Publishes Final Rule on Statewide and Metropolitan Planning

The Federal Highway Administration (FHWA) has published a [final rule](#) to update the regulations governing the development of metropolitan transportation plans and programs for urbanized areas, long-range statewide transportation plans and programs, and the congestion management process as well as revisions related to the use of an reliance on planning products developed during the planning process for project development and the environmental review process. These changes reflect the passage of the Moving Ahead for Progress in the 21st Century Act (MAP-21) and the Fixing America's Surface Transportation (FAST) Act. This final rule is effective June 27, 2016.
