
# Persons with Disabilities Placards and License Plates: Best Practices in Deterring and Detecting Fraud and Misuse Now Available!



The AAMVA Disability Placard/Plate Fraud Working Group announces the release of AAMVA's newest member resource. The new resource, entitled, Persons with **Disabilities Placards and License Plates:** Best Practices in Deterring and Detecting Fraud and Misuse, aims to help member jurisdictions improve the issuance process for disability placards and plates, deterrence and detection of fraud in these areas, and the enforcement of disability parking violations. Member jurisdictions are encouraged to use the guide as a starting point for an informed local discussion on how best to marry needs for accessible parking with needs for general parking. The Best Practices Guide includes a total of 40

recommendations that jurisdictions may choose to adopt. Sample statutory language and recommended standards is also provided. Read more here.

#### Mobile Drivers License (mDL) in Australia



The subject of mobile driver licenses (mDL) was on prominent display at the recently held Technology in Government conference in Canberra, Australia last week. This was the inaugural debut of a special Digital ID component to the event. Mark Lowe, Director of lowa's Department of Transportation, Geoff Slagle, AAMVA's Director, Identity Management, and Arjan Geluk, Chairman ISO WG10/TF14 & UL Transaction Security were invited to present on the mDL work happening within North America and Europe. Individual presentations were made and a panel was held for attendees to learn what was happening with the mDL standardization

work in ISO, the exploratory experiences of mDL pilots, and the unfolding mDL implementation in Iowa. South Australia also provided an overview of an mDL implementation that they have rolled out, and discussions were held with other states/territories that are in the preparation stage for future implementations.

NMVTIS State Web Interface (SWI) — Understanding the Administrative Features

Tuesday, August 14, 2018, 2:00 - 3:00 pm (ET) The NMVTIS SWI Web

Application is used by the states to perform title verification and data corrections.

This webinar focuses on how the states use the administrative features to oversee the states user community. A brief overview of the SWI application is also provided. The SWI application has been built so that each state manages their own user community. This includes configuring the system with organizations to which users are assigned. The state administrator is responsible for user role assignments and user account activation and deactivation. The SWI Application also includes a reporting component that allows state administrators to monitor user activity.

## **Delaware DMV Launches Voluntary Medical ID Indicator**

The Division of Motor Vehicles will begin incorporating a medical indicator onto the Delaware driver licenses or identification cards as of Wednesday, August 8, 2018. The medical symbol will be displayed on the front of the card and the back will identify the individual's condition so that law enforcement officers and first responders can adjust treatment accordingly. State Representative Valerie Longhurst explained how the program was initiated: A constituent came to me concerned about his son's medical condition and how it could be misunderstood if an officer pulled him over while driving. It raised concerns about a larger issue that we wanted to address. Read more here.

## Ontario Provincial Police Report Multiple Long Weekend Road Deaths, Final Results For "Move Over" Campaign, Other Traffic Charges

The Ontario Provincial Police (OPP) dealt with a tragic Civic Day Long Weekend with two children among the six people who died on OPP-patrolled roads. The weekend marked the highest number of fatal road incidents since the 2011 August long weekend. With its data now finalized, the OPP laid 511 Move Over charges during its four-day Move Over campaign. There were 413 charges during the 2017 campaign and 471 charges the previous year (2016). The OPP laid 8,566 traffic-related charges over the weekend. A total of 5,070 charges were for speeding, with officers laying an additional 136 street racing/stunt driving charges against motorists who were caught driving more than 50 kilometres per hour over the posted speed limit. By comparison, the 2017 Civic Day Long Weekend resulted in 8,781 charges, 5,558 of which were speeding offences and 127 of which were street racing/stunt driving offences. Read more here.

# MDVA and MDOT MVA Announce Redesigned Disabled Veteran License Plate

The Maryland Department of Veterans Affairs (MDVA), in collaboration with the Maryland Department of Transportation Motor Vehicle Administration (MDOT MVA), announced today the release of its redesigned Disabled Veterans license

plate. The idea for a new plate came after George Durgin, Capt., U.S. Public Health Service and Maryland resident, saw a variety of veteran plates with patriotic designs at Walter Reed National Military Medical Center. Capt. Durgin contacted the MDVA's Outreach Program and suggested a new plate design. He provided photos of other state's plates which served as a baseline for the MDOT MVA's design of a new Maryland military plate for disabled veterans. The plate is now available at the MDOT MVA for eligible veterans. Read more here.

## WYDOT Upgrades to New, More Secure Temporary Tags

Wyoming's temporary vehicle tags are getting a makeover to make them more secure and to prevent fraud. The Wyoming Department of Transportation is moving from the green temporary tags to a non-destructible white tag, featuring a hologram sticker. Two auto dealers in Cheyenne will start issuing the new white temporary tags starting this week. The new temporary tag also includes the year, make and color of the vehicle, while the current ones don't. The new tags are designed to be mounted to the rear bumper, in the same manner as a regular license plate. A number is assigned to the temporary tag, which must match the number on the hologram. The new temporary tags also have an expiration date, similar to the current green temporary tags, and a temporary placard that is removed and kept in the vehicle with the owner's information. Besides improved security, dealers and counties will now get their tags electronically. Instead of buying temporary tags from WYDOT, dealers and counties will log into a website and print out the placard. Read more here.

# FMCSA Requests 'Driver Completion of Knowledge and Skills Tests' be Added to State Information Collections

The Federal Motor Carrier Safety Administration (FMCSA) is requesting approval to revise and renew an information collection request (ICR) titled, "Commercial Driver Licensing and Test Standards," due to an increased number of commercial driver's license records. The ICR includes one additional item beyond those being requested as an extension of current collections: "Driver completion of knowledge and skills tests 49 CFR 384.201." FMCSA indicates that this has been added as a result of a new requirement for State to assure the testing of commercial learner's permits follow a standardized testing procedure. FMCSA states the intent of the ICR is to ensure that drivers, motor carriers and the States are complying with notification and recordkeeping requirements for information related to testing, licensing, violations, convictions and disqualifications and that the information is accurate, complete and transmitted and recorded within the time periods required by the Commercial Motor Vehicle Safety Act of 1986. Impacts on State driver's license agency respondents as a result of the ICR are estimated to be 422,255 hours for 4,746 state respondents. "Comments on the ICR are due by October 9, 2018. # NHTSA Submits ICR on Hazard Perception and Distracted Driving Training Intervention for Teens

The National Highway Traffic Safety Administration (NHTSA) has submitted an information collection request (ICR) for approval. The ICR relates to "Hazard Perception and Distracted Driving Training Intervention for Teens," proposing that NHTSA collect information from newly-licensed teen drivers for a one-time voluntary study to evaluate Risk Awareness and Perception Training (RAPT). RAPT is a hazard perception and distracted driving training intervention to improve novice safety. The collection would include drawing samples from two states to determine participation and before and after RAPT performance. Read more here.

### Missouri Department of Revenue Submits CDL

#### **Knowledge Exemption Renewal Request**

The Missouri Department of Revenue has submitted an application for exemption renewal from Federal Motor Carrier Safety Administration commercial driver's license (CDL) regulations. The previously granted exemption allowed the Missouri DOR to waive the mandatory knowledge test requirement for qualified veterans who participated in dedicated training in approved military programs. The Missouri DOR seeks to assist qualified veterans in obtaining employment when returning to the civilian workforce and the exemption application would allow them to continue to waive knowledge test requirements for qualified veterans. ## **NHTSA Submitting Youth Drowsy Driving ICR To OMB**

The National Highway Traffic Safety Administration (NHTSA) announced the Information Collection Request (ICR) entitled, "In-Vehicle Drowsiness Detection and Alerting" will be submitted to the Office of Management and Budget (OMB) for review and comment. NHTSA is seeking approval to collect information from licensed young drivers for a one-time, voluntary driving simulator study of the effectiveness of in-vehicle drowsiness detection and alerting systems that aim to reduce drowsy driving. NHTSA proposes to collect information from licensed young drivers to determine (1) their eligibility to participate in a study evaluating systems designed to detect and mitigate drowsy driving, (2) their driving performance during a simulated driving task to measure drowsiness mitigation system effectiveness, and (3) their opinions about the safety systems and their perceptions of the benefits. Comments must be received on or before September 7, 2018. Read more here.

# FMCSA Boss Martinez Talks Driver Shortage, Potential for Hours Reforms with Commercial Carrier Journal (CCJ)

Ray Martinez, who has helmed the Federal Motor Carrier Safety Administration since February, spoke with CCJ in a half-hour phone interview Tuesday, discussing topics ranging from carriers' difficulties in hiring and retaining drivers, the potential for hours of service changes, the coming of autonomous vehicles, the industry's transition to ELDs and the direction he'd like to see the agency move under his watch. FMCSA is planning a "robust listening session" for the fall to address reforms to the agency's Compliance, Safety, Accountability program, Martinez said. The date has not yet been set, but Martinez said he hopes to glean as much input as possible from industry stakeholders to help address the future of the safety program. Read more here.
