- **Foreign National Driving Credentials (NHTSA)**
 - Completed September 10, 2011
 - Training presentation and resource card mailed to law enforcement Sept 2011
- **Comparative Data (FMCSA)**
 - Completed December 31, 2011
 - Datasets from 8 jurisdictions are online and available for searching
 - Follow-on activities funded by NHTSA
- **Driver Record Data Translation (Both)**
 - Completed December 31, 2011
 - Final report submitted that identifies best practices DMV's can use to provide improved driving records to the judiciary.

- **Motorcycle Operators Manual**
 - Incorporated final comments into the Knowledge Test Item Pool questions
 - Received approval from NHTSA to begin development of the 3-Wheel Vehicle Item Pool
 - Work continues with Georgia on their participation in the MOM pilot
- **Comparative Data**
 - Datasets from over 23 jurisdictions are online and available for searching
 - Grant funding of \$3,000 is still available to jurisdictions to assist in the data entry process

- **NDR Working Group**

- First conference call held February 22nd
- Developed preliminary list of suggested improvements to NDR procedures and regulations

- **DLA Support**

- DLA adoption has halted due to economic and REAL ID concerns
- Request submitted to NHTSA extending end date until 6/30/14 to allow additional time for jurisdictions to begin DLA implementation

- **International Driver Examiner Certification (IDEC)**
 - IDEC Board met December 13 – 14, 2011
 - Incorporated ICE video on DMV Identity and Benefit Fraud into the CDE curriculum
 - Added Customer Service Delivery & Road Test Intervention modules to the CDE curriculum
 - Updated CDE materials scheduled for release Spring 2012
 - IDEC Board approved the Maryland CDE & CCE application
 - IDEC Board approved the creation of a video on how to conduct a basic driving test

- **CDL Train-the-Trainer**
 - Next CDL Train-the-Trainer class scheduled for April 23 – 27, 2012 in St. Petersburg, FL
 - 2005 CDL Test System Examiner Update classes (2) tentatively scheduled for September 2012
 - Additional Train-the-Trainer and CDL Test System update classes will be held in 2013 & 2014.
- **2012 CDL Coordinator/IT Meeting**
 - Tentatively scheduled for late September 2012. Location to be determined.
 - Available funding will cover 4 jurisdictional attendees. Two from the CDL area and 2 from the IT area.

- **Motorcycle GDL Best Practices Working Group**
 - Proposal approved by Steering Committee
 - Work had been postponed pending NHTSA review and approval of draft Motorcycle Operators Manual (MOM) and draft 3-wheel vehicle supplement.
 - NHTSA has given initial approval to MOM and 3-wheel supplement so work will begin on this task. Working Group will be identified in early Spring 2012 with first meeting anticipated for Summer 2012.

- **Solicitation for volunteers issued**
 - February 29 deadline
