ISO IIN Block Number Assignment

A.1 Issuer Identification Number Summary:

On January 19, 1993, John H. Strandquist, CAE, AAMVA Executive Director issued a memorandum which established the following procedures for obtaining a Issuer Identification Number. This memorandum is to ensure that each jurisdiction is assigned an identification number that maintains some order, as requested by the Magnetic Stripe Subcommittee. An application to ANSI requesting the issuance of a sequential block of 63 Issuer Identification Numbers (IIN) for the membership of AAMVA was submitted on August 11, 1992. On November 17, 1992, AAMVA received a reply from ISO approving the request.

A.2 Identification Number Procedures:

AAMVAnet's Standards Administrator is the "Block Coordinator" for the issuance and distribution of the IIN's contained within the AAMVA block assignment. Therefore, IINs beginning with 636000 and ending with 636062 has been reserved for the use of AAMVA member jurisdictions.

Each jurisdiction must apply directly to AAMVA for their IIN. The following process must be followed:

- I. Complete and submit the ISO IIN application form; Annex B.
- II. Submit a \$50 application/processing fee. Checks must be in U.S. funds and drawn on a U.S. bank. Make Checks payable to **AAMVA**; and
- III. Complete and submit the AAMVA Self Certification Form. Annex C.

Once the above material has been received by AAMVA and approved, your IIN will be issued. Annex D is a listing of the member jurisdictions who have been issued their IIN since the inception of these procedures. As additional members are issued their IIN this list will be updated by the AAMVAnet Standards Administrator.
