SAVE User Agencies Can Comment on Revisions to Form G-845

USCIS' [SAVE Program](#) recently submitted revised electronic and paper versions of [Form G-845](#) to the Office of Management and Budget (OMB) for

review. A 60 day public comment period, announced in the [Federal Register](#), opened on September 26, 2014. Final OMB approval of the revised versions is expected by April 2, 2015. The current versions of the G-845 will remain valid (despite their January 31, 2015 expiration dates). Departments of Motor Vehicles and Drivers Licensing Agencies that are registered with the SAVE Program use Form G-845 to verify the immigration status of benefit applicants, so only those individuals entitled to benefits receive them.

TSA Administrator John Pistole to Retire

John S. Pistole, the Transportation Security Administration's longest serving administrator, announced his retirement from public service, effective Dec. 31, 2014, following more than 31 years in the federal government, including four and a half years at TSA and 26 years at the FBI. In the coming weeks, Administrator Pistole is expected to be named to a position in academia beginning in early 2015. John S. Pistole was nominated for the TSA

Administrator position by President Barack Obama in May 2010. He received unanimous confirmation by the United States Senate, assuming his new role in June 2010. Pistole joined the FBI in 1983 after practicing law for two years. For more information, visit tsa.gov

Executive Order: Improving the Security of Consumer Financial Transactions

President Obama issued an executive order on Friday aimed at securing consumers' financial data. The executive order is meant to put in place federal safeguards on payment processing as well as a direct reference in Section 3 regarding implementation of recommendations aligned with the National Strategy for Trusted Identities in Cyberspace to ensure that all agencies making personal data accessible to citizens through digital applications require the use of multiple factors of authentication and an effective identity proofing process.
