#### Governor Cuomo Highlights Dramatic Reduction in DMV Wait Times (New York)

Governor Andrew M. Cuomo today highlighted a dramatic reduction in wait times at offices of the New York State Department of Motor Vehicles. In September 2014, the average wait time at State-run DMV offices was reduced to 30 minutes – down from an average of 72 minutes in March 2013. This represents a decrease of 58 percent in customer wait time, and was achieved through the DMV's Customer Service Initiative, which the agency began at Governor Cuomo's direction in 2012. # More Moped, Scooter Rules Considered at NC Legislature

The debate over regulating mopeds in North Carolina resumed Tuesday as legislators heard new rule suggestions from the Division of Motor Vehicles just months after the General Assembly mandated owners register the vehicles. DMV Commissioner Kelly Thomas said lawmakers also may consider requiring moped or motor scooter operators to have a driver's license or state identification card and to

## Colorado to Reduce Immigrant Driver's License Program After Funding Request Rejected

## Coming to a car near you: electronic license plates

With wireless connectivity, digital license plates could alert authorities when a car has been stolen or its registration has expired. An uninsured driver cruising down the freeway has nowhere to hide from police. License plates, seemingly drawn from science-fiction, give him away by flashing a message telling everyone his coverage has lapsed. It's a future pushed by Compliance Innovations, a South Carolina startup developing the technology. The idea is to replace metal license plates—used for almost as long as cars have existed—with digital screens that are connected wirelessly to mobile phone networks. Instead of merely showing a jumble of letters and numbers, the futuristic plates could be used to alert law enforcement by flashing messages like "Stolen," "Amber Alert," and "Expired registration." ## **Did You Know**

#### **SUPER BOWL XLIX**

In case you didn't know, Super Bowl XLIX between the New England Patriots and Seattle Seahawks is on Sunday, February 1st. Here are some fun facts about the Big Game to chew on:

- The last five Super Bowls have been the five most watched telecasts in U.S. television history, prior to that the most watched telecast was the M\*A\*S\*H finale in February 1983 with 106 million viewers. (Nielsen)
- Despite all the tuning sources now available, the audience for the Super Bowl has increased 22.4 million viewers over the past ten years 2004-2014. (Nielsen)
- Females accounted for 46.8% of the Super Bowl audience last year. The average audience for females was a record high 52.6 million. By comparison, The Oscars last year had 43.7 million TOTAL viewers. This was the fourth straight year the Super Bowl had averaged over 50 million female viewers. During the regular NFL season about one-third of the viewing audience is female. (Nielsen)
- A:30 ad in the 2015 Super Bowl cost \$4.5 million, the most expensive ad in history and a 12.5% increase from last year's game. On average, Super Bowl ad rates have grown 10.8% annually. (Kantar Media)
- The number of advertising time has increased from 40 minutes and 15 seconds in 2005 to 49 minutes and 15 minutes in 2014. The 2013 Super Bowl had 51 minutes and 40 seconds of ad time the highest to date. (Kantar Media)The median age of The Super Bowl viewer in 2014 was 43.7, a slight increase from the previous year 43.5. (Nielsen)
- If winning the Super Bowl was not enough motivation, players on the winning team get paid \$97,000.
- Super Bowl players on the losing team taking home \$49,000.
