#### The NMVTIS Business Rules Working Group Meets



The NMVTIS Business Rules Working Group met in New Orleans, Louisiana on May 13 and 14, 2015. They continued to work on the third edition of the NMVTIS Best Practices for Registration and Title Managers scheduled to be released at the end of 2015. In addition to the best practices, the working group also discussed the state program performance management strategy and feedback received from the 2015 Spring Workshop and tools for the

jurisdictions to assess the levels of participation. The group said farewell to Scott Clapper from Delaware and Eric Brown from Florida while welcoming Nancy Blair from Ohio, Brion Gappa from Florida, and Cindy King from Delaware to the working group. It was a very productive and successful meeting.

#### **System Modernization Working Group Meets**

AAMVA's System Modernization Working Group recently met for the first time in St. Louis, Missouri to start work on developing a best practices document. The group spent an intensive two days talking about their own projects and white boarding ideas for best practices in dozens of operational areas. The purpose of the working group is to gather information from AAMVA members, associate members, and other stakeholders to gather, organize and share information with the AAMVA community related to the lifecycle management of modernized and/or redesigned driver license and vehicle systems. The group is planning four meetings over the next two years with periodic releases of best practices information to help those currently engaged in a system redesign effort. Working Group members will be reaching out to jurisdictions who have system modernization experience with a request to share their lessons learned and best practices for incorporation to the final document. Industry will also be solicited for their input.


#### e-Odometer Task Force Webpage

In response to the outcome of the E-Title Proof of Concept and Roadmap, AAMVA approved the E-Odometer Disclosure Task Force to work toward a solution for electronic odometer disclosure processes that would protect the consumers and allow enough flexibility for states to evolve from a time consuming paper process to an electronic process. In anticipation of NHTSA prescribing regulations to permit written disclosures or notices and related matters to be filed electronic the Task Force developed multiple considerations concerning e-odometer disclosure processes that should be taken into account for all stakeholders. Flexibility was a key factor in developing the report in order to allow states an option to implement within budgetary constraints. The report also considers the specific actions within the process and the importance of authenticating the disclosure.

#### **CSTIMS and ROOSTR Participation Update**



Both Nevada and Washington State are now using CSTIMS in production, joining 16 other states in using the tool for day-to-day management of their commercial skills testing. CSTIMS is a valuable tool for monitoring examiners and will be a great asset in complying with the Commercial Learner's Permit rules which go into effect on July 8, 2015.

The following states have signed up for Report Out-of-States Test Results (ROOSTR) Lite application: Minnesota, Maryland, Arkansas, Nebraska, and Hawaii. ROOSTR Lite is AAMVA's web based solution for jurisdictions to exchange out-of-state CDL Skills Test results in accordance with CFR §383.79. Please note that the ROOSTR Lite solution only applies to jurisdictions that do not plan on utilizing AAMVA's Commercial Skills Test Information Management System (CSTIMS) application for managing CDL Skills Testing, Training, and Audits.

#### **Kentucky State Police Unveil "The Trooper"**



Kentucky's top law enforcement agency has a new 10-foot-tall symbol of its history. A bronze statue entitled "The Trooper" was unveiled Monday at the Kentucky State Police Training Academy. State police Commissioner Rodney Brewer says the statue is a permanent tribute to the state police troopers and officers who made the ultimate sacrifice by giving their lives in the line of duty. Twenty-eight troopers and officers have been killed in the line of duty. State police officials say the sculptor, Benjamin Victor, took personal interest in his creation of the trooper statue. They say he was diligently sensitive to the image of the modern-day Kentucky trooper, carefully remaining true to all details of the iconic uniform. No public funds were used to

## FBI Releases 2014 Preliminary Statistics for Law Enforcement Officers Killed in the Line of Duty

Preliminary statistics released by the FBI show that 51 law enforcement officers were feloniously killed in the line of duty in 2014. This is an increase of almost 89 percent when compared to the 27 officers killed in 2013. (Note: From 1980–2014, an average of 64 law enforcement officers have been feloniously killed per year. The 2013 total, 27, was the lowest during this 35year period.) By region, 17 officers died as a result of criminal acts that occurred in the South, 14 officers in the West, eight officers in the Midwest, eight in the Northeast, and four in Puerto Rico. By circumstance, 11 officers died from injuries inflicted as a result of answering disturbance calls (one of which was a domestic disturbance). Ten officers were conducting traffic pursuits or stops, eight were killed as a result of ambushes (six due to entrapment/premeditated situations and two during unprovoked attacks), and six officers were investigating suspicious persons or circumstances. Five officers sustained fatal injuries while they were performing investigative activities, four while they were engaged in tactical situations, three officers were handling persons with mental illness, and one officer was slain during a drug-related matter. #### **House Appropriations Committee Passes Spending Measure**

The House Appropriations Committee has passed its \$55.27 billion FY 2016 appropriations bill by a vote of 30-21. While the \$55.27 billion in discretionary spending is \$1.5 billion up from the current \$53.8 billion level it would keep highway spending at current levels and boost funding for the Federal Aviation Administration and housing programs. The measure represents \$9.7 billion less than the Presidential request. This reduction comes at a time when Transportation Secretary Foxx has been pushing aggressively for long-term. sustained, and significant increases in transportation funding to aid the nation's crumbling infrastructure, aid in safety, and promote commerce on a global level. Besides the debate over sufficient spending amounts, the measure carries some significant policy riders as well. The two major policy sections of note are those that would amend the truck size and length provisions for combination vehicles, and a section that would suspend enforcement related to hours of service provisions for truckers. The legislation also provides that no funds may be used towards regulations that would increase the levels of minimum financial responsibility for transporting passengers or property. Finally, the legislation would also do away with NHTSA's National Roadside Survey. Though the draft bill remains unnumbered, a full legislative analysis is available to AAMVA members in the Government Affairs section of the AAMVA Web site. The measure will now move to full committee consideration.

## USDOT, NHTSA Plan to Require All Future Vehicles to Talk to Each Other to Prevent Crashes

Vehicle-to-vehicle communication technology has the potential to revolutionize road safety and driving in general, and it could become the norm in just a few years. Transportation Secretary Anthony Foxx said on Thursday the U.S. Department of Transportation and the National Highway Transportation Safety Administration plan to fast-track a proposal that requires all new vehicles to have vehicle-to-vehicle communication (V2V), according to Fortune. The technology prevents crashes by allowing cars to

communicate speed, direction, position and other safety-related information. The DOT anticipates that V2V could prevent up to 80 percent of crashes involving unimpaired drivers. The NHTSA previously announced it was beginning to take the steps towards requiring V2V technology in early 2014. But the Office of Management and Budget wasn't expected to review the rule until late next year. However, Foxx said that the DOT has told NHTSA to speed up the process. #### **NHTSA Releases New Study on DUI Recidivism**

Recently released research from the National Highway Traffic Safety Administration (NHTSA) is giving communities new reasons to consider hightech solutions to combat drunk driving. In April NHTSA published a study that looked at how 24/7 transdermal alcohol monitoring bracelets impact the longterm criminal behavior of drunk drivers. The results show that the technology nearly eliminated repeat offenses while in use, delayed the occurrence of additional drunk driving offenses, and when worn for a period of at least 90 days, significantly reduced the rate of recidivism in one of the two jurisdictions in the study. The results also showed that age and gender can be significant predictors of future, repeat DUIs. Conducted by the Preusser Research Group, the study, Comparative Study and Evaluation of SCRAM Use, Recidivism Rates, and Characteristics, looked at more than 3,000 DUI offenders in Wisconsin and Nebraska who had offenses occurring between 2007 and 2009. Researchers defined recidivism as re-arrest for an alcohol driving offense occurring up to two years post-monitoring. For more information, visit here.
