### NMVTIS Law Enforcement Working Group Seeks Volunteer

The purpose of the [NMVTIS Law Enforcement Working Group](#) is to identify requirements for law enforcement's use of NMVTIS, and to increase awareness and usage of the NMVTIS Law Enforcement Access Tool. This Working Group operates under the auspices of the [AAMVA Law Enforcement Standing Committee](#) and normally meets in-person once per year. Allowable meeting travel expenses are paid by AAMVA.

As part of the NMVTIS reengineering effort, a Help Desk feature was created to allow states to correct their title and brand data on the central site. When states perform their own data corrections the timeliness and accuracy of the data corrections improves substantially. This webinar is focused on explaining the capability of the Help Desk feature as included in the SWI. ## New Minnesota Driver's License and State ID Design Unveiled

Minnesotans will see newly designed driver's licenses and ID cards in the coming weeks as the state transitions from the current cards that were first issued in 2004. Cardholders will see some differences in the new design, and the new cards have a variety of security features making them more difficult to forge. The new design will be applied to all driver's license and ID cards issued by the State of Minnesota, including REAL ID-compliant cards and the Enhanced Driver's License and ID cards. ## Crashes Hit All-Time High in B.C.; ICBC Launches Online Test to Refresh Drivers' Knowledge & Improve Road Safety

A total of 350,000 crashes occurred in 2017 – about 960 a day, which is a 25 per cent increase since just 2014. A new survey conducted by Insights West for ICBC's Drive Smart road safety campaign reveals that bad driving habits continue to persist as well. What could be contributing to some of the bad driving habits is the loss of driving knowledge. Two-fifths of drivers admitted that there are rules of the road they've likely forgotten. To encourage drivers to continually refresh their knowledge and help make our roads safer, ICBC is launching the [Drive Smart Refresher Test](#), a free online tool on B.C.'s driving rules. ## FHWA Holds National Dialogue on Highway Automation Public Meetings

The Federal Highway Administration (FHWA) is holding a [National Dialogue on Highway Automation](#) through a series of public meetings across the country to seek input on the integration of automated vehicles on the Nation's roadways. The objectives of the public meetings are: (1) To engage with a diverse group of stakeholders to understand key issues regarding automated vehicles and their implications for roadway infrastructure; and (2) to gather input on highway automation to help inform FHWA research, policy, and programs. The public meetings will have presentations and breakout sessions during which participants can provide input to FHWA and DOT representatives. The National Dialogue meetings began on June 26 and will continue through the end of 2018. Tentative meetings include the following:

- Week of July 30, 2018: National Workshop 2: Data and Digital Infrastructure (Seattle, Washington)
- September 2018: National Workshop 3: Freight (Chicago, Illinois)
- October 24-25, 2018: National Workshop 4: Operations (Phoenix, Arizona)
- November 14-15, 2018: National Workshop 5: Infrastructure and Multi-Modal Safety (Austin, Texas)

## **NHTSA Announces Ignition Interlock Programs ICR Submission**

The National Highway Traffic Safety Administration (NHTSA) will be submitting the Information Collection Request (ICR) titled "State of the Practice of Ignition Interlock Programs" to the Office of Management and Budget (OMB) for review. Highway safety officials and traffic safety advocates identified a need for an inventory of interlock programs to support program management by documenting lessons learned and identifying solutions to common problems. Respondents will be administrators and staff of alcohol ignition interlock programs. There are up to 52 interlock programs with nearly one in each state, the District of Columbia, and Puerto Rico. Administrators would be invited to take a 15-minute online self-administered questionnaire, and administrators and staff would be invited to participate in a semi-structured interview over the telephone, up to one hour (with one interview per program).
