Tasks related to on-boarding North Carolina will be conducted during the weekend of February 9th. During this process (Saturday evening to Monday morning), there may be periods during which the CDLIS/S2S Central Site is in inquiry-only mode or is unavailable (over and above the regularly scheduled maintenance window of 2AM to 5AM on Sunday, February 10th).

[NMVTIS State Web Interface \(SWI\) – Instant Title Verification Using the VIN Search Feature](#)

**Tuesday, December 18, 2018, 2:00 pm - 3:00 pm (ET)**

Before a jurisdiction issues a title or other ownership document or record, the SWI can provide information to help the jurisdiction determine whether the ownership documentation presented with the application are valid. The information supports jurisdictions' titling processes for both new and used vehicles. The Anti-Car Theft Act requires each jurisdiction to perform an instant title verification check before issuing a title to an applicant claiming to have purchased the vehicle from an individual or entity in another jurisdiction. The SWI VIN search feature can be used to satisfy this legal requirement. In addition, the NMVTIS best practice is that jurisdictions perform an inquiry before issuing a title or other ownership document or record, whether or not the applicant claims to have purchased the vehicle in another jurisdiction.

### California DMV Reminds Drivers to 'Save the Space' for Those with Disabilities

The California Department of Motor Vehicles reminded Californians to 'save the space' designated for disabled individuals who legally display their disabled person parking placards. 'With parking at a premium during the holiday season, it is important to remember that misusing a disabled person parking placard is not only against the law, but it negatively impacts the mobility of those with disabilities,' DMV Director Jean Shiomoto said. ### Oregon to Update Driver License, ID Card Design

The next time you renew your Oregon driver license or identification card you may see a new design with new security features. DMV is rolling out a new card design starting this winter and early 2019. The beauty of the new cards isn’t just skin deep. The enhanced colorful look is part of the new card’s advanced security features, making it harder to alter or duplicate...This is the first major upgrade to the card technology in Oregon since 2003. In addition to the new look and security features, the new card will provide a vertical layout for provisional driver license holders – drivers younger than 21 years old. This will make it easier to identify minors where age restrictions apply, such as the purchase of alcohol. [Read more here.](#)

### Congress Passes Real ID Act Modification for Freely Associated States

The United States Congress has passed HR 3398, the Real ID Act Modification for Freely Associated States Act. While still awaiting Presidential signature, this legislation amends the Real ID Act of 2005 to permit Freely Associated States to meet identification requirements under the Real ID Act. The legislation would modify the minimum requirements standards for compliance with Real ID such that evidence of lawful status includes “valid documentary evidence that the person is a citizen of the Republic of the Marshall Islands, the Federated States of Micronesia, or the Republic of Palau who has been admitted to the United States as a nonimmigrant pursuant to the Compact of Free Association between the United States and the Republic or Federated States.” [Read more here.](#)

### FHWA Seeks Renewal Information Collection for DL Suspensions for Drug Offenders

The Federal Highway Administration (FHWA) is renewing an existing information collection entitled “Drug Offender’s Driver’s License Suspension Certification.” The collection concerns state requirements to enact and enforce laws that revoke or suspend the driver’s licenses of any individual convicted of a drug offense and make annual certification to the FHWA on their actions. Under 23 USC 159, a State must submit by January 1 of each year either a written certification, signed by the Governor, stating that the State is in compliance with these requirements; or a written certification stating that the Governor is opposed to the enactment or enforcement, and that the State legislature has adopted a resolution expressing its opposition. Comments on the ICR renewal are due by February 11, 2019. [Read more here.](#)

### GAO Releases 2018 State and Local Government Fiscal Outlook

The U.S. Government Accountability Office (GAO) has released its 2018 State and Local Governments’ Fiscal Outlook. GAO’s simulations suggest that the state and local government sector will likely face an increasing difference between revenues and expenditures during the next 50 years, as reflected by the operating balance. While both expenditures and revenues are projected to increase as a percentage of gross domestic product (GDP), a difference between the two is projected to persist because expenditures are expected to grow faster than revenues throughout the simulation period. ## AAA Research Shows the Danger of Driving with Old Headlights

Are you driving with old or dirty headlights? AAA research suggests that's a bad idea. New test results from AAA show that clouded or yellow headlights only generate more than 20 percent the amount of lights that new headlights do, which means dangerous nighttime driving. AAA urges drivers to check their headlights for signs of deterioration and invest in new headlights or, at a minimum, a low-cost service to boost the safety of driving after dark. And dangerous driving isn't the only downside of cloudy lights. 'Clouded or yellow headlights are a safety issue,' said Matt Nasworthy, Florida Public Affairs Director, AAA – The Auto Club Group. 'In some states, motorists can be ticketed for headlights that significantly reduce visibility.' [Read more here.](#)

SafeWise is a new member of the Road to Zero Coalition this year and they are working on a national campaign that will sponsor sober rides home on New Year's Eve. Their Safe Rides Campaign will be offering \$10 Lyft codes to residents in the 5 states with the highest fatality rates from alcohol-impaired driving in order to discourage drunk driving over New Years. ## Progress Achieved Reducing Drunk Driving in Canada, but Renewed Efforts Needed: Poll (TIRF)

The Traffic Injury Research Foundation (TIRF) is pleased to release a new fact sheet summarizing findings about self-reported drinking and driving behaviour in Canada. This fact sheet is based on the Road Safety Monitor (RSM) 2018 poll conducted by TIRF, in partnership with Beer Canada and Desjardins Insurance. Despite considerable gains in reducing drinking and driving in recent years, these results, which are strongly correlated with fatal alcohol-crash data, could be an early warning sign that progress may be slipping. ## TIRF USA Releases Road Safety Monitor: Alcohol-Impaired Driving in the United States, 2018

The Traffic Injury Research Foundation USA, Inc. (TIRF USA), in partnership with TIRF in Canada and with sponsorship from Anheuser-Busch, is pleased to release a new fact sheet summarizing findings about self-reported alcohol-impaired driving behavior in the United States. This fact sheet is based on the Road Safety Monitor (RSM) 2018 online poll conducted by TIRF USA of a random, representative sample of 1,500 U.S. drivers aged 21 years or older. Results suggest that many individuals who continue to drive after drinking rely on how impaired they feel and may not appreciate how alcohol can impair their judgment or their driving ability.
