The New Jersey Motor Vehicle Commission (NJMVC) proudly nominates Safety Specialist 2 Glenn Baran for the American Association of Motor Vehicle Administrators' (AAMVA) 2016 International Driver Examiner Certification (IDEC) of the Year award.

Mr. Baran started his career at the NJMVC as a Safety Specialist 1 in 2011, administering road tests for auto, motorcycle and commercial vehicles.

In 2014, Glenn was assigned to the Commercial Driver's License (CDL) Mobile Compliance Unit. The CDL Mobile Compliance Unit is a highly trained unit, which is deployed statewide to perform training and audits at all road test sites. The unit also conducts bulk CDL testing and ensures all sites are in compliance with the Federal Motor Carrier Safety Administration rules and regulations and NJMVC policies and procedures.


