# IRP, Inc. Board of Directors

- **Strategic Plan:** IRP values:
- Leadership; 2) Transparency; 3) Inclusiveness; 4) Collaboration

*In keeping with the values of the Strategic Plan, the IRP Board of Directors is focusing on four primary elements to strengthen the Board's effectiveness as the leaders of IRP, Inc. emphasize, analyze and share the impacts of emerging technologies and expand inclusiveness between the Board and its membership and partner organization through improved communication and collaboration.*

- **Set Direction**

- Short term - Invite "Futurist" to speak at IRP Annual Meeting to stay aware of emerging transportation issues and identify ways to engage millennials.
- Long term - Develop process to address emerging issues and its effect to the motor carrier realm.



# IRP, Inc. Board of Directors

- **Ensure and Protect Resources**
  - Short term - Restructure board meeting agenda to mainstream emerging issues and ensure time is spent on focused discussion on these topics during the meeting.
  - Long term - Orient new IRP Board members on unique culture and issues.
- **Engage in Outreach**
  - Short term - Provide high level overview of key highlights and action items of the Board to the membership and partner organizations.
  - Long term – Spend time at the regional breakouts at the IRP Annual Meeting asking what kind of outreach would be most helpful.



# IRP, Inc. Board of Directors

- Provide Oversight
  - Short term - Add an IRP Executive Committee member as lead liaison to each committee to provide a mentoring opportunity to new board members,
  - Long term - New Board member orientation with a focus on mission and strategic plan.





# Education and Training

- IRP, Inc. is currently evaluating educational and training needs of the membership
- Hope is to develop online training that will be beneficial to the membership and provide a product that addresses a good deal of the need
- Currently developing a survey, that will take place in the short future, to obtain information from the membership



# Education and Training

- IRP, Inc. is working with IFTA, Inc. staff to determine if we can do this project jointly.
- Hope is that we can use the same tool to provide training online, which will mean the look and feel of the product will be the same for both memberships.
- There are other benefits, but the primary focus is to provide a good product that can meet the needs of our joint memberships.



# IRP Clearinghouse

- In 2016, over \$836 million dollars were exchanged through the IRP Clearinghouse.
  - This represents only the funds netted and exchanged between the 56 IRP jurisdictions that currently participate in the Clearinghouse
  - Estimated that over 2.7 billion dollars is generated by IRP registrations annually
  - There were over 2.6 million IRP vehicles registered in 2015
  - Waiting for IRP Annual Activity reports currently to see what the numbers for 2016 were



# IRP Clearinghouse

- IRP Clearinghouse Standardization Project
  - We are currently working with jurisdictions to standardize the data in the Clearinghouse
  - This project is to ensure that all data needed by jurisdictions to adequately verify other jurisdictions are properly calculating fees is provided and to ensure that necessary data is being provided by all jurisdictions



# Electronic Credentials Task Force

- The joint Electronic Credentials Task Force is still working on development of a plan for moving forward to establish electronic credentials or to move in the direction of making the electronic record the required credential.
- Hope to have a face to face meeting of the task force in the coming months.
