2016 DL/ID Card Design Standard Now Available



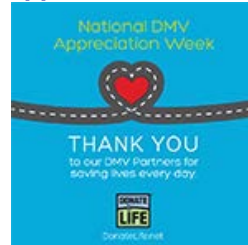
The AAMVA [DL/ID Card Design Standard](#) (CDS) provides for the design of driver licenses (DL) and identification (ID) cards. Its intent is to improve the security of the DL/ID cards and the level of interoperability among cards issued by all North American jurisdictions. Maintained by the Card Design Standard committee, the CDS is updated as needed based on evolving business needs of issuing agencies. NHTSA Project Officer for the AAMVA Autonomous Vehicle Working Group. For the last 18 months, the working group has been researching, discussing and gaining an understanding of automation in vehicles and the impact it will have on motor vehicle and law enforcement agencies. The two days in Kansas City were spent reviewing, revising, and editing the draft guidance document for jurisdictions, which will include recommendations for regulating the testing and deployment of automated vehicles. It is anticipated that the guidance will be available in the winter of 2017.

[NMVTIS State Web Interface \(SWI\) – Instant Title Verification Using the VIN Search Feature](#)

Before a jurisdiction issues a title or other ownership document or record, the SWI can provide information to help the jurisdiction determine whether the ownership documentation presented with the application are valid. The information supports jurisdictions' titling processes for both new and used vehicles. The Anti-Car Theft Act requires each jurisdiction to perform an instant title verification check before issuing a title to an applicant claiming to have purchased the vehicle from an individual or entity in another jurisdiction. The SWI VIN search feature can be used to satisfy this legal requirement. In addition, the NMVTIS best practice is that jurisdictions perform an inquiry before issuing a title or other ownership document or record, whether or not the applicant claims to have purchased the vehicle in another jurisdiction.

Ontario Online Consultation for Gender and Sex on Government IDs and Form

The Province of Ontario launched an online portal to collect public and stakeholder consultations to help develop and create a broad policy on how ministries collect, use, retain and display sex and gender information on public-facing government forms and products. Since June 13, 2016 all Ontario photo health cards have been printed without indicating the cardholder's sex. The Province is also taking steps to offer the option of an Ontario driver's licence with an (X) in the "sex" field for those that don't identify exclusively as male (M) or female (F). Anyone interested can participate in the online consultation and be notified when the "X" identifier option becomes available, which is scheduled for early 2017. Child Passenger Safety Week, September 18 to 24: WisDOT Video Shows How to Use Child Safety Seats Properly

Motor vehicle crashes are a leading cause of death for children, according to the Centers for Disease Control. During national Child Passenger Safety Week from September 18 to 24, the Wisconsin Department of Transportation (WisDOT) will use social media (Twitter: [@WisconsinDOT](https://twitter.com/WisconsinDOT) and Facebook: [Facebook.com/WisDOT](https://www.facebook.com/WisDOT)) as well as other messaging to remind adults that properly securing children in vehicles can be a matter of life or death. Second Tribal Transportation Self-Governance Program Negotiated Rulemaking Committee to Meet

The Federal Highway Administration (FHWA) [has announced](#) the second meeting of the Tribal Transportation Self-Governance Program (TTSGP) Negotiated Rulemaking Committee, which took place on September 13-15 at the Eastern Federal Lands Highway Division in Sterling, VA. The purpose of this group is to develop a Notice of Proposed Rulemaking that contains the regulations required to carry the Tribal Transportation Self-Governance Program, establish the committee, and conduct the negotiated rulemaking in a manner that reflects the unique government-to-government relationship between the Indian tribes and that federal government. Members of the public are invited to comment on the docket by referencing Docket Number FHWA-2016-002. AAMVA members submitting comments are encouraged to copy governmentaffairs@aamva.org.
